If the Minister was aware, members would like to know why a copy of the analysis of responses to the consultation was not made available to the Committee in advance of the briefing session in order to inform its decision on accelerated passage. Furthermore, the committee would like to know if the department sought or received information from the Office for National Statistics in relation to the Bill.
