### 1. Apologies

### 2. Chairperson's Business

### 2.1 Special Educational Needs (SEN) briefings

The Chairperson advised Members that the Education Authority had indicated that it would not provide a briefing as requested on 11 March 2020 on SEN delivery including particularly issues with statementing. It was understood that the Education Authority had informally indicated that it would be inappropriate to provide the briefing until the relevant internal audit report on statementing is available.

Agreed: The Committee agreed to write to the Minister indicating its disappointment that the Education Authority was unable to provide a public briefing on the important question of SEN statements and seeking the earliest possible sight of the internal audit report and an early date for the oral briefing on SEN delivery and statementing issues. The Committee also agreed to seek a further and more detailed breakdown of recent SEN allocations.

### 2.2 Informal Meetings

The Committee discussed scheduling of upcoming informal meetings.

Agreed: The Committee agreed to endeavour to restrict informal meetings to the last two Tuesdays of every month when the Assembly is in session.

# 5. Department of Education – 2020-21 Budget Recap and 2017-22 Programme for Government (PfG) out-turns – Evidence Session

The evidence session was reported by Hansard.

Officials provided the Committee with an overview of the Department's 2020-21 budget submission and its current 2017-22 PfG out-turns.

This was followed by a question and answer session.

The Committee noted: a copy of the Department of Education's 2020-21 budget submission to the Department of Finance; relevant extracts from the Spring Supplementary Estimates and Vote on Account documents; and recent forwarded correspondence from the Minister of Finance in respect of end of year 2019-20 allocations.

The Chairperson thanked officials for their attendance.

Agreed: The Committee agreed to write to the Department in respect of teaching and non-teaching redundancies, requesting an oral briefing and seeking:

- teaching and non-teaching redundancy figures for previous years and information on the Department's plans in this regard going forward;
- further information on the current number of classroom assistants and the probable impact of the Department's plans on the numbers of these nonteaching employees;
- an analysis of the value for money for previous and planned teaching and non-teaching redundancy schemes; and
- clarification on the Department's plans for the Investing in the Teaching Workforce scheme.

Agreed: The Committee agreed to write to the Department regarding issues related to underachievement requesting an oral briefing on Extended Schools and the Partners in Education programme and seeking:

- further clarification in respect of related budget bids;
- information on the level of inter-departmental and inter-agency cooperation undertaken as part of the delivery of the Extended Schools programme;
- clarification on the nature of and timescale for its planned consultation on Partners in Education;
- further details on the North Belfast Extended Schools pilot which includes thematic autonomy for principals; and
- information on Extended School schemes in the North West of Northern Ireland.

Agreed: The Committee also agreed to write to the Department seeking information on and examples of fee-paying schools with charitable status which are entitled to claim rates relief.

Agreed: The Committee agreed to write to the Department seeking information on how school maintenance is prioritised.

Agreed: The Committee agreed to write to the Department regarding school deficits and seeking details of the schools that have cumulative deficits of around £1m or higher as well as estimates of their ongoing in-year deficits.

Agreed: The Committee agreed to write to the Department indicating its support for nurture provision in schools and the maintenance of effective funding structures. The Committee further agreed to indicate its opposition to the discontinuation of funding for nurture in the existing 31 schools and to seek clarity on how the £2.5m of proposed nurture funding is to be allocated.

Agreed: The Committee agreed to write to the Department seeking access to further information on 2017-22 PfG out-turns and a briefing on the development of the system-level education dashboard.

Agreed: The Committee agreed to write to the Department seeking further information on the attainment gap indicators and clarification on the number of children in receipt of Free School Meals and otherwise excluded from the PfG GCSE statistics.

Agreed: The Committee agreed to write to the Department on the role of Physical Education (PE) in the curriculum and the PfG in respect of emotional health and wellbeing.

Agreed: The Committee agreed to write to the Department seeking clarity on Sure Start and Early Years Pathway funding.

Agreed: The Committee agreed that it was content to forward Departmental briefing papers to the Committee for Finance.

### 6. BookTrust NI - Bookstart Funding - Oral Briefing

Agreed: The Committee agreed to write to the Minister indicating its support for BookTrust NI's bid for £50,000 towards the costs of its Babypack programme. The Committee further agreed to ask the Minister to consider: the considerable value for money benefits of the different BookTrust NI packages; their impact on tackling limited rural access to library resources; the usefulness of including programmes of this kind in a future PfG (as a way of supporting parental involvement in children's

education); and the scope for cooperation with other departments in order to fund these complementary early intervention measures.

Agreed: The Committee further agreed to write to the Committee for Health seeking its support for the BookTrust NI bid.

Agreed: The Committee agreed write to BookTrust NI in order to arrange further literacy promotion engagement.
