### **1. Apologies**

No apologies were received.

### **2. Assessment, Restart and Contingency Planning - Minister of Education Oral Briefing**

The Committee noted a briefing paper from the Department of Education; the Minister's statement to the Assembly on the Council for the Curriculum, Examinations & Assessment (CCEA) assessment arrangements; a response from the Minister on Restart; a response from the Minister on Alternative Examination Arrangements; a response from the Minister on School Restart and the Summer Programme; a Department of Education response on CCEA awarding arrangements and a CCEA response on Alternative Examination Arrangements.

**Agreed:** The Committee agreed to write to the Minister to endorse his submission of papers to the Executive with a view to gaining commitment to a childcare strategy before the end of the mandate; seeking to be kept up to date on the provision and demand for counselling services, and urging that he not delay but press ahead with a bid for further resources to address the waiting list and possible delayed trauma; and commending the primary school counselling pilot, while also asking how schools were selected and details of the schools taking part.

**Agreed:** The Committee agreed to write to CCEA urging publication of the appeals process as soon as possible and before its briefing on 2 June 2021.

**Agreed:** The Committee agreed to write to the Department of Education asking what measures and bespoke interventions are in place to support Irish Medium schools following the Pandemic, whose pupils suffered disproportionately from school closure without the immersive environment critical to their learning.

**Agreed:** The Committee agreed to write to the Department of Education seeking details of the activities which have been planned for a summer programme.

**Agreed:** The Committee agreed to write to the Education Authority seeking:

- Information on the roles and responsibilities of the Child Protection Support Service (CPSS);
- How parents refer a complaint to CPSS;
- The threshold for CPSS to refer a complaint to Social Services; and
- How many times CPSS has referred a parental complaint regards the actions of a school, school staff or Board of Governors to Social Services; and
- How many times a school has been reported to Social Services overall

**Agreed:** The Committee agreed write to the Department of Education asking how it had engaged with stakeholders on this matter and how it intended to continue this engagement going forward.

**Agreed:** The Committee agreed to write to the Department of Education to reiterate its endorsement of mandatory autism training and to stress the need for the guidance to address the use of mechanical or chemical restraint.

The Chairperson thanked the witnesses for the briefing.
