#### NISRA Report on 2020/21 Sick Leave Absence in NICS

The Committee noted correspondence dated 29 June 2021 via Business Office regarding NISRA's Report on 2020/21 Sick Absence in NICS. The annual report provides a detailed analysis of sickness absence for staff in the Northern Ireland Civil Service over the 2020/2021 financial year – when the majority of staff will have been working from home. The report also contains analyses of trends over the last five years and highlights the absence figure for 2020/2021 as **9.8 days** (average days lost per staff year), which is a considerable decrease from 12.9 days in the previous year. The absence level for 2020/2021 is the lowest absence level recorded for over 22 years. However, this also cost the public purse £28 million in lost production.

**Agreed:** The Committee noted the Report and agreed to request further information regarding the conclusions coming out of the report.

#### Mid Ulster District Council - Broadband Investment

The Committee noted correspondence received on 2 July 2021 from Councillor Paul McLean, Mid Ulster District Council, regarding NIAO Broadband Investment Report and a motion on broadband investment, which was passed at the Council's June meeting.

'That in light of the recent NIAO Report into Broadband Investment in the North of Ireland, we welcome the findings of this report, a report which is strongly critical of achieving value for money in delivering broadband provision for citizens of the North. We further note the findings within the report and request that any financial clawback's due from BT should be immediately redirected into Broadband provision into rural areas with poorest broadband speeds'.

**Agreed:** The Committee noted Councillor McLean has also written to the Department for the Economy, and other relevant Governmental Department charged with the reallocation of any monies.

The Committee noted correspondence dated 1 July 2021 from Mr Denis McMahon, AO DAERA regarding the Ministerial Direction *to provide short term support for the impact of COVID-19 on Lough Neagh inland fishermen*, which did not include the submission to the Minister. A copy of the submission has since been provided to the Northern Ireland Audit Office.

**Agreed**: The Committee noted Mr McMahon's rationale for the recommendations and noted some information in the submission is still redacted, in line with the right of Legal Privilege.

#### **Ministerial Direction**

The Committee noted correspondence from Mr Kieran Donnelly C&AG dated 2 July, regarding a 'Revised Ministerial Direction, DfC: Recognition Payment for Supporting People and Homelessness Sector Frontline Staff'.

The Committee noted the Ministerial Direction is one that has already been considered by the Committee on recognition payments for supporting people and homelessness frontline staff. In the initial communication of the Ministerial Direction, the payment to these staff was limited to a gross payment of £569 with an estimated cost of £2.5 million. This payment is increased to £735 each and at a cost to the Department of £3.5 million, ensuring that the payment allows for tax and national insurance deductions. It is identical to payments made under a recognition scheme by the Minister for Health also under a Ministerial Direction.

**Agreed:** The Committee noted the relevant documents including sign off by the Minister for Communities, Deirdre Hargey MLA.
