# **Assembly Members (Remuneration Board) Bill - Amendments**

When the we appeared at the meeting of the Ad Hoc Committee on 20 February 2025, and in our letter of 7 March 2025, we notified the Committee of the Assembly Commission's intention to bring forward amendments to the Bill regarding clause 4 of the Bill which deals with temporary appointments.

The Assembly Commission has now prepared amendments to put more detail into the Bill in relation to temporary appointments.

In particular, the amendments ensure that the full suite of disqualification and termination provisions in Part 1 of the 2011 Act are also applied to temporary appointments, and to make clear that only one former member could ever be a Member of the Board at any one time. The following italicised text has been prepared by the draftsperson:

For new sub-section 6A(9)<sup>1</sup> is substituted—

'(9) Subject to the preceding provisions of this section, a temporary appointment is to be treated for all purposes (including, for example, for the purposes of section 5) as if it were an appointment under section 4(1).'

New sub-section 6A(10) then provides that—

'(10) But an order under subsection (7) may disapply or modify a provision of this Act (other than section 4(4)) in its application to a temporary appointment.'

<sup>&</sup>lt;sup>1</sup> This sub-section currently provides that 'Subject to the provisions of this section or of any order under subsection (7), a temporary appointment is to be treated for all purposes as if it were an appointment under section 4(1).'

New sub-section 6A(9) applies the disqualification and termination provisions of the preceding provisions of Part 1 of the 2011 Act to temporary appointments. A power to enable the Assembly Commission to by order modify the application of one or more of the provisions of Part 1 of the 2011 Act for temporary appointments is retained.

However, new sub-section 6A(10) makes clear that this power cannot be used to modify the application of section 4(4) of the 2011 Act. (Section 4(4), which is inserted by new clause 5(2) of the Bill states that 'At any one time no more than one Board member may be a former member of the Assembly').

As per our previous correspondence, the Assembly Commission proposes that if it is required to bring forward an order, it would be the Audit Committee which would be asked to scrutinise that order.

# Assembly Members (Independent Financial Review and Standards) Act (Northern Ireland) 2011

# 2011 CHAPTER 17

An Act to make provision for a Panel to determine the salaries, allowances, pensions and gratuities payable to members and former members of the Northern Ireland Assembly; to make provision for a Northern Ireland Assembly Commissioner for Standards; and for connected purposes. [29th March 2011]

BE IT ENACTED by being passed by the Northern Ireland Assembly and assented to by Her Majesty as follows:

# PART 1

# THE REMUNERATION BOARD

Establishment and functions

# Establishment and membership of the **Board**

- 1.—(1) There shall be a body known as the <u>Remuneration Board</u>.
- (2) The members of the **Board** are the Chair and two other members.

# Functions of the **Board**

- 2.—(1) The functions of the <u>Board</u> are to make determinations as to—
  - (a) the salaries payable to members of the Assembly under section 47 of the 1998 Act; and
  - (b) the pensions and gratuities payable under section 48 of that Act.
- (2) The <u>Board</u> shall exercise its functions with a view to achieving the objectives of—
  - (a) ensuring probity, accountability and value for money with respect to the expenditure of public funds;
  - (b) securing for members of the Assembly a level of remuneration which—
    - fairly <u>reflects</u> the complexity and importance of their functions as members of the Assembly; and

    - (a) a person's membership of the Assembly begins on the day on which the person takes his or her seat in accordance with standing orders; and
    - (b) a person's holding of an office within subsection (6) begins on the day on which the person takes up office.
- (6) An office is within this subsection if the salary payable under section 47 of the 1998 Act to a member of the Assembly holding the office is higher than the salary payable under that section to members of the Assembly generally.
- (7) For the purposes of this section, a person who is a member of the Assembly immediately before the Assembly is dissolved shall be treated—
  - (a) if the person continues to hold office as a Minister or junior Minister, as Presiding Officer or deputy or as a member of the Commission, as if the person were a member of the Assembly until the end of the day on which he or she ceases to hold the office; and
  - (b) if the person does not fall within paragraph (a) but is nominated as a candidate at the subsequent general election, as if the person were a member of the Assembly until the end of the day of the poll for that election.
  - (8) In this section—

"deputy", in relation to the Presiding Officer, means any deputy Presiding Officer elected under section 39 of the 1998 Act;

"junior Minister" means a person appointed as a junior Minister under section 19 of the 1998 Act;

"Minister" has the meaning given by section 7(3) of the 1998 Act.

# Contents of determinations: pensions and gratuities

**13.**—(1) This section applies to any determination made under section 2(1) (b).

(2) A determination to which this section applies may include provision for—

- (a) contributions or payments towards provision for pensions or gratuities;
- (b) the establishment and administration (whether by the Commission or otherwise) of one or more pension schemes.
- (3) Where any salary payable to a person under section 47 of the 1998 Act is not payable because of either or both of sections 47A and 47B of that Act, any provision made under this section for the payment of pensions which has effect in relation to that person shall apply as if the salary were payable.

- **34.**—(1) This section applies to any complaint or matter which on the day on which section 17 comes into operation—

**35.** The Commission shall be a rule-making authority for the purposes of the Statutory Rules (Northern Ireland) Order 1979 (NI 12).

# **Consequential amendments**

**36.** The amendments in Schedule 5 (being amendments consequential on the provisions of this Act) shall have effect.

# **Interpretation:** general

37.—(1) In this Act—

"the 1998 Act" means the Northern Ireland Act 1998 (c. 47);

"the Commission" means the Northern Ireland Assembly Commission;

"the Commissioner" means the Northern Ireland Assembly Commissioner for Standards established by section 16;

"the Presiding Officer" means the Presiding Officer of the Assembly elected under section 39 of the 1998 Act; and

"staff of the Assembly" means staff appointed by the Commission under paragraph 2(1) of Schedule 5 to the 1998 Act.

(2) "Standing Order 69A" means Standing Order 69A of the standing orders of the Assembly as amended on 29 June 2010 and includes any provision in the standing orders of the Assembly amending or replacing Standing Order 69A.

# Commencement

- **38.**—(1) The following provisions come into operation on the day on which this Act receives Royal Assent—
  - (a) Part 1 and Schedules 1 and 2;
  - (b) in Part 2, sections 16, 18 to 24 and Schedules 3 and 4;
  - (c) this Part and Schedule 5.
- (2) The other provisions of this Act come into operation on such day or days as the Commission may by order appoint.

  - (o) the Northern Ireland Assembly Commissioner for Standards;
  - (p) the Comptroller and Auditor General for Northern Ireland;
  - (q) the Attorney General for Northern Ireland; and
  - (r) a person who has been the Attorney General for Northern Ireland at any time in the 5 years prior to the date when the appointment is to take effect.
- 2. For the purposes of paragraph 1(c), a person becomes a candidate for election to the Assembly on the day on which that person becomes a candidate within the meaning of section 118A(1) and (2) of the Representation of the People Act 1983 (c. 2) as applied to the Assembly by Article 3 of the Northern Ireland Assembly (Elections) Order 2001 (SI 2001/2599).
