NIPSO: 2025-26 Main Estimates

I refer to the email of 6th May 2025 seeking briefing from NIPSO on the 2025-26 Main Estimates for the Audit Committee meeting on Wednesday 14th May 2025.

2025-26 Main Estimates.

In accordance with the Assembly Audit Committee's remit to approve the Estimates for NIPSO, I have attached NIPSO's Main Estimate for 2025-26. However, it is important to note, that while we have endeavoured to ensure accuracy of these, it is possible that DOF may wish - through discussion with NIPSO to make final editing changes to the narrative or figures therein during the course of finalising these Estimates for laying in the Assembly, inclusion in the Budget Bill and publication. In the unlikely event that any of these would have any bearing on the budget figures previously agreed by the Committee I will of course ensure that these are brought to the Committee's attention.

For the purposes of this briefing I attach at Annex A the pivotal financial schedule from our Estimates submission, namely the "Part 1" sheet. Please note that a number of other worksheets within the overall Estimates document support this particular summary sheet and provide further analysis of the figures.

I can confirm that the figures contained within the Estimates are consistent with the 2025-26 NIPSO budget that the Committee has previously agreed and in respect of which the Committee Chair wrote to the Finance Minister on 15 November 2024. We would, however, draw your attention to an additional reconciling item relating to £37k depreciation. The adjustment arose due to an error in reporting between NIPSO and DoF and will be corrected at the June 2025 monitoring round to align Estimates and the Committee agreed budget.



Extract from NIAAC Committee Chair's letter to the Finance Minister:

Arising from its scrutiny of the NIPSO budget plan for 2025-26, the Audit Committee agreed that the Executive's Budget document should make provision for NIPSO having a Resource DEL Budget of £5,150K and Capital DEL Budget of £0K. The Resource DEL broken down as follows: £4,950K of Non Ring-Fenced DEL and £200K of Ring-fenced DEL (subject to the outcome of the Pay and Grading exercise).
