**The Social Fund (Child Funeral Fund) (No. 2) (Amendment)

The Department for Communities makes the following Regulations in exercise of the powers conferred by sections 134(1)(a) and (4), 171(1) and (3) to (5) of the Social Security Contributions and Benefits (Northern Ireland) Act 1992(a) and sections 1(1) and (1C), 5(1)(a), (j), (k) and (5) and 165(4) of the Social Security Administration (Northern Ireland) Act 1992(b) and now vested in it(c).

Citation and commencement

1. These Regulations may be cited as the Social Fund (Child Funeral Fund) (No. 2) (Amendment) Regulations (Northern Ireland) 2026 and shall come into operation on 00 Month 2026.

Amendment of the Social Fund (Child Funeral Fund) Regulations

2.—(1) The Social Fund (Child Funeral Fund) (No. 2) Regulations (Northern Ireland) 2022(d) are amended as follows.

(2) In regulation 4 (provisions against double payment)—

(a) delete “or” in sub-paragraph (b);

(b) in sub-paragraph (c) for “.” substitute “; or”;

(c) after sub-paragraph (c) insert—

“(d) a payment has been made in respect of funeral expenses arising from the death of the same person from a Health and Social Care Trust, unless the amount paid by the Health and Social Care Trust is less than a Child Funeral Fund Payment, in which case a payment may be made for an amount not exceeding the remainder of the value of a Child Funeral Fund payment.”.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations will prevent double payments by allowing a Child Funeral Fund payment to be refused where payment has already been made from a Health and Social Care Trust.

Regulation 1 provides that the Regulations shall come into operation on XX XX 2026.

Regulation 2 prohibits payment from the Child Funeral Fund in respect of funeral expenses for which payment has already been made from a Health and Social Care Trust, except where the payment received from a Health and Social Care Trust is for an amount less than a Child Funeral Fund payment, in which case an amount may be paid to the value of the remainder of the Child Funeral Fund payment.

A regulatory impact assessment has not been produced for these Regulations as they have no impact on the costs of business.
