**REQUEST FROM: FINANCE COMMITTEE – DALO READOUT - MEETING
WEDNESDAY 6 MAY 2026**

Point 5 – Economy Committee: Utility Regulator (Support for Decarbonisation Preparation) Bill: The Committee would ask the Department to consider this Bill and indicate if it has any remit or if there is any relevant policy locus within the Bill's provisions. This will inform a response to the Economy Committee.

Response –

- The Utility Regulator (Support for Decarbonisation Preparation) Bill was agreed by the Executive in March 2026 and subsequently introduced to the Assembly on 20 April 2026.
- This legislation will provide the Utility Regulator with a legislative duty to provide the Department for the Economy (DfE) with advice, information, or assistance to support the development of energy policies necessary, which will help the Executive deliver against the Climate Change Act NI (2022) targets and the Executive's Energy Strategy objectives.
- In terms of financial implications, DfE expect the costs of the Utility Regulator's support to DfE in developing net zero policies would be met by licence fees paid by electricity and gas companies. Licence fees may only be used to fund work for net zero policy related to the Utility Regulator's statutory electricity and gas functions. Any assistance from the Utility Regulator outside the scope of statutory electricity and gas functions cannot be funded in this way.
- DfE have acknowledged that the Utility Regulator and DfE will engage with the Department of Finance (DoF) in advance of any expenditure being incurred to consider the implications for the public purse. DoF's position is that any additional expenditure arising should, in the first instance, be met by the sponsoring department. While there may be scope to seek additional resources through in-year monitoring rounds, the Committee will be aware of the significantly constrained budgetary environment within which such bids would be considered.
- DoF has no direct policy remit in respect of the Utility Regulator (Support for Decarbonisation Preparation) Bill. However, it has a relevant interest in several policy areas, including building regulations, energy performance certification or public buildings energy and emissions. It is anticipated that there will be arrangements in place so that DoF officials can draw on the support and engagement from the Utility Regulator's new function.

Dear Peter,

1. Thank you for your memo of 1 May 2026 seeking the views of statutory committees on the Utility Regulator (Support for Decarbonisation Preparation) Bill.
2. The Committee for Communities has considered the matter and confirms a Nil Return. Given the nature of the Bill, the Committee has set out below a brief explanation of the basis on which it has reached that position, together with an observation regarding subsequent legislation.
3. In reaching its position, the Committee considered the Bill as introduced, the accompanying Explanatory and Financial Memorandum, the oral evidence provided by Department for the Economy officials to the Committee for the Economy on 22 April 2026, and the Official Report of the Bill's Second Stage debate on 28 April 2026.
4. The Committee notes that the Bill is short and technical in nature. Its single substantive clause confers on the Northern Ireland Authority for Utility Regulation (the Utility Regulator) a power to provide advice, information or assistance to the Department for the Economy in connection with the development of any proposal, policy, strategy or plan relating to the energy sector under the Climate Change

Act (Northern Ireland) 2022, together with a qualified duty to comply with reasonable departmental requests so far as reasonably practicable.

5. The Bill does not, of itself, alter any energy policy, impose or remove any obligation on any person, body or service user, or create or amend any function exercisable by any body within the Department for Communities' remit.
6. On that basis, the Committee for Communities is satisfied that the Bill, as introduced, does not engage the statutory responsibilities of the Department for Communities. The substantive decarbonisation policy choices to which the Bill relates – including heat policy, the future treatment of low-carbon heat technologies, and the cost-distributional consequences of the transition – do not arise on the face of this Bill. They will instead fall to be made in the subsequent programme of energy and decarbonisation legislation foreshadowed in the evidence given to the Committee for the Economy.
7. The Committee wishes, however, to record that it regards this Bill as the legislative gateway to that wider programme of decarbonisation policy, and that the programme will, in due course, engage the Department for Communities' remit more directly, in particular regarding heat policy and the social and supported housing stock, the relationship between decarbonisation policy and the Anti-Poverty Strategy 2025–2035, and the application of just transition principles to low-income households.
8. The Committee for Communities accordingly looks forward to engaging on the subsequent decarbonisation legislation that will more directly engage its remit.
