As you will be aware the UK charity sector is operating in a very challenging environment. According to the Value of Giving index charitable donations have fallen from £9.5bn pre pandemic and the Cost of Living crisis to £5bn, whilst demand for support has surged.

Since your announcement in the House of Commons on 21 May 2024 on compensation in response to the report's publication, the haemophilia patient organisations have been inundated with calls and emails from our community confused and concerned about the implications. <u>As</u>We are small organisations <u>already</u> struggling to raise income you can imagine the additional burden this has incurred, however we still have the responsibility to provide the support for everyone in the UK with a bleeding disorder and advocate for the patient voice.

Sir Brian Langstaff included in his recommendations <u>in thewithin</u> Infected Blood Inquiry <u>final</u> report the importance of giving patients <u>this a</u> voice. Further <u>than</u> that the patient voice <u>should</u> be enabled and empowered by charities <u>who should receiving receive</u> funding specifically for patient advocacy including the UK Haemophilia Society, Haemophilia Scotland and Haemophilia Northern Ireland.

The Haemophilia Society has invested over £600k from its reserves since 2018 in our work supporting the Infected Blood Inquiry and our members infected and affected. We are not immune to the challenges across the charity sector which has, according to Third Sector magazine, -seen more charities close in the last 6 months than in the last 6 years combined.

If our organisations are not to join that shocking statistic we need <u>interim\_long term</u> financial support<u>immediately or at least initially an immediate interim contribution</u> to continue to advocate for our community at this pivotal stage in the long campaign for truth and justice. We would welcome the opportunity to meet to discuss further.
