ROAD TRAFFIC AND VEHICLES

**The Waiting Restrictions (Coalisland) Order (Northern Ireland)
2026**

Made - - - - *27th February 2026*

Coming into operation *23rd March 2026*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) (“the 1997 Order”) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with Article 4(6) of, and paragraphs 1 and 2 of Schedule 1 to, the 1997 Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Waiting Restrictions (Coalisland) Order (Northern Ireland) 2026 and shall come into operation on 23rd March 2026.

(2) In this Order—

“medical practitioner” means a fully registered person within the meaning of section 55(1) of the Medical Act 1983^(d);

“postal packet” has the same meaning as in section 65(1) of the Postal Services Act 2011^(e);
and

“universal service provider” has the same meaning as in section 65(1) of the Postal Services Act 2011.

Restriction of waiting

2. Save as provided in Article 3, a person shall not cause or permit a vehicle to wait at any time on the lengths of road specified in the Schedule.

Exceptions

3.—(1) Nothing in Article 2 shall render it unlawful for a person to cause or permit a vehicle to wait on the carriageway of the lengths of road specified in the Schedule where the person in control of it is prevented from proceeding by circumstances beyond that person's control or to avoid an accident or for so long as may be reasonably necessary to enable—

- (a) a person to board or alight from a vehicle provided that such boarding or alighting does not cause the vehicle to wait in the same place for more than 2 minutes;
- (b) the vehicle to be used in an emergency by a medical practitioner, or for fire and rescue, ambulance, police or customs purposes or for the purposes of the security forces;
- (c) the vehicle to be used by or on behalf of a universal service provider for the purposes of the delivery to, or collection from, premises situated adjacent to the length of road of postal packets;
- (d) the vehicle, if it cannot conveniently be used for such purposes outside that length of road to be used—
 - (i) in connection with any building, repair or demolition operations;
 - (ii) in connection with the removal of any obstruction to traffic;
 - (iii) by or on behalf of a district council or a government department in pursuance of statutory powers or duties;
 - (iv) by or on behalf of a sewerage undertaker or a water undertaker in connection with the discharge of that undertaker's functions;
 - (v) in connection with the discharge of the functions of the holder of a licence granted under Article 10 of the Electricity (Northern Ireland) Order 1992(a) or a licence granted under Article 8 of the Gas (Northern Ireland) Order 1996(b); or
 - (vi) in connection with the installation, laying, erection, alteration or repair of any electronic communications apparatus as defined in paragraph 5 of Schedule 3A to the Communications Act 2003(c).

(2) Nothing in Article 3 shall render it unlawful to cause or permit a vehicle to wait on the carriageway of a length of road specified in the Schedule for so long as may be reasonably necessary to enable goods to be loaded or unloaded from the vehicle.

(3) For the purposes of paragraph (1)(a) a vehicle shall be deemed to wait in the same place for more than 2 minutes if any one part of the carriageway is below any part of the vehicle or its load (if any) throughout a period exceeding 2 minutes whether or not the vehicle is moved during that period.

Revocation

4. The Parking Places on Roads and Waiting Restrictions (Coalisland) Order (Northern Ireland) 2024(d) is revoked.

SCHEDULE

Article 2

WAITING RESTRICTIONS IN COALISLAND – No Waiting at any Time (loading and unloading permitted)

1. Barrack Square (north-east side) – from a point 15 metres south-east of its junction with Lineside for a distance of 45 metres in south-easterly direction.
2. Station Road (north side) – from a point 15 metres west of its junction with Dungannon Road for a distance of 19 metres in a westerly direction.
3. Stewartstown Road (east side) – from a point 15 metres south of its junction with Washing Bay Road for a distance of 10 metres in a southerly direction.
4. Stewartstown Road (west side) – from a point 15 metres south of its junction with Main Street for a distance of 10 metres in a southerly direction.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order prohibits vehicles waiting at any time (loading and unloading permitted) on the length of Station Road, Coalisland as specified in the Schedule. Vehicles are excepted from the prohibition in certain circumstances.

The Order will also revoke and re-enact certain other waiting restrictions in Coalisland.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of this Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and the Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the prohibition relating to Station Road, Coalisland specified above will in due course be placed on the road.
