**The Parking and Waiting Restrictions (Belfast) (Amendment)
Order (Northern Ireland) 2026**

Made - - - - 2026

Coming into operation 2026

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) (“the 1997 Order”) and now vested in it^(c).

In accordance with Article 4(6) of, and paragraphs 1 and 2 of Schedule 1 to, the 1997 Order, the Department has consulted such persons as it considered appropriate.

The Department has published a notice in compliance with paragraphs 1 and 3 of the Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as the Parking and Waiting Restrictions (Belfast) (Amendment) Order (Northern Ireland) 2026 and shall come into operation on 2026.

Amendment

2.—(1) The Parking and Waiting Restrictions (Belfast) Order (Northern Ireland) 2025^(d) is amended in accordance with paragraph 2(2).

(2) In Part 2 of Schedule 2 after item no. 171 add the following item—

“172. Upper Knockbreda Road (east side in a lay-by) – from a point 29.3 metres north-east of its junction with Saintfield Road for a distance of 4.5 metres in an easterly direction then for a distance of 11 metres in a north-easterly direction and then for a distance of 4.5 metres in a north-westerly direction totalling 20 metres.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Parking and Waiting Restrictions (Belfast) Order (Northern Ireland) 2025 (“the Order”) by the addition of a no waiting at any time (loading and unloading not permitted) prohibition on the length of road specified in Article 2(2).

Vehicles are excepted from the prohibition in certain circumstances.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and the Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
