- Dfl's assessment of the circumstances where developers can currently contribute to the water and waste water infrastructure;
- an update on the Department's letter of 2 July 2024 regarding the elements that will be used to determine the 'transport budget' for the purposes of the calculation of 10% spend for active travel under the Climate Change Act (Northern Ireland) 2022; and



 written evidence on Dfl's submission to the Department of Finance for the October MR.
