#### 2. Draft Minutes

The Chairperson reminded members that the Committee has previously agreed to pursue work in relation to homelessness as one of its strategic priorities and that this work would include an event in in the new year.

Agreed: The Committee was content with a proposal from the Clerk that the event be developed in conjunction with stakeholders and that it take place in the Long Gallery, Parliament Buildings, on 16 February 2017. Given that the Committee agreed that there is a need to take a multi-disciplinary approach to homelessness, the Committee agreed to invite the chair of the Committee for Justice and chair of the Health Committee to participate.

*Agreed:* The Committee agreed to consider how similar cross-committee work may be taken forward in relation to domestic violence.

*Agreed:* The Committee agreed the draft FWP (as amended to include the homelessness event on 16 February 2017)

Agreed: The Committee agreed to include representatives from Utility Street Men's Hostel, Sandy Row, in its homelessness stakeholder event in February.
