These include: provision of a publically accessible electronic register of licenses; actions being taken by government departments to address alcohol related harm to coincide with the Bill; and the issue of the minimum pricing of alcohol in the context of last week's ruling by The Court of Session in Edinburgh against a challenge by the Scotch whisky industry which claimed minimum pricing of alcohol was a breach of European Law.
