**1. 2015-16 Draft Budget scrutiny – Public Finance Scrutiny Unit – Assembly Research – oral briefing**

The Committee received an oral briefing from Assembly Research Public Finance Scrutiny Unit regarding the scrutiny of the 2015-16 Draft Budget.

**Agreed:** The Committee agreed to write to the Department commenting on the absence of information in respect of the Draft Budget and seeking clarity, in advance of the briefing scheduled for 3 December 2014, regarding:

- DE's plans to encourage Arms Length Bodies (including the Education Authority) to make use of Financial Transaction Capital funding, the Change Fund and European Investment Bank support for capital or other projects;
- the level of contractual commitments in respect of capital and resource funding;
- the level and treatment of accruing resources available to the Department and its ALBs; and
- the linkage between the 2015-16 Draft Budget and Programme for Government targets.

**Agreed:** The Committee agreed to commission a paper from Assembly Research on the financing of education services in other jurisdictions.

The Chairperson reminded Members that the Minister for Health, Social Services and Public Safety had recently made a statement on the Marshall Report on Child Sexual Exploitation. The report included commitments from the Education Minister that all children are to receive preventative education and that further advice and guidance will be made available to schools, parents and carers.

**Agreed:** The Committee agreed to write to the Department seeking further information, prior to the briefing on iMatter on 10 December 2014, on the Department's plans in this regard.

##### **5.3 Informal meeting with teaching unions on the NITPS**

The Chairperson discussed the Committee's informal meeting which took place on Tuesday 18 November 2014 with representatives of the teaching unions in respect of the Northern Ireland Teachers' Pension Scheme.

**Agreed:** The Committee expressed concerns in respect of the complexity of the proposed changes to the NITPS and agreed to write to the Department

calling on it to do more to explain teachers' pension options and to provide information/clarity on:

- the current and expected age profile of retirees;
- the number of union representatives on the new pensions board;
- the provision of a pensions' calculator and annual statements for teachers;
- the reported lack of pensions expertise in managing authorities;
- whether a 10 year gap is to be maintained between Normal Pension Age and the earliest age for retirement;
- whether further early retirement phased options are being explored;
- whether there are any guarantees in respect of a limit to further increases in contributions for teachers;
- whether teachers electing to retire early and making additional contributions are obliged to make this decision at the start of their careers; and
- the numbers of Further Education lecturers who are current members of the NITPS and the nature of any consultation with this group in respect of the proposed reforms to the NITPS.

**Agreed:** The Committee also agreed to write to the teaching unions seeking a breakdown of their membership and information in respect of retirees.

#### **5.4 Christmas Cards**

The Committee discussed whether it would issue hard copy Christmas cards and deferred further consideration of this matter.

#### **5.5 Youth Services for Irish Medium Education**

Members noted a recent Departmental press release relating to enhanced support for youth services in the Irish Medium Education sector in particular £130k for additional opportunities for informal learning in the Irish language.

**Agreed:** The Committee agreed to write to the Department seeking sight of the relevant business case and an explanation in respect of the allocation of additional funds for this purpose.
