The meeting commenced in private session at 9:49am.

1. Shared Education Bill - legal advice - Assembly Legal Services

Assembly Legal Services joined the meeting at 9:49am.

The Committee considered legal advice relating to the Shared Education Bill.

The Committee noted tabled correspondence from the Department in respect of Committee amendments to the Shared Education Bill.

A question and answer session followed the briefing.

Assembly Legal Services left the meeting at 10:01am.

Agreed: The Committee agreed to write to the Department seeking clarity in respect of a Departmental amendment relating to the inclusion of children with no religious belief in Shared Education, for consideration at the meeting of 20 January 2016.

Agreed: The Committee agreed that Members would likely consider, at Further Consideration Stage, the Departmental text designed to revise the Committee amendment relating to a duty on the Department in respect of Shared Education, which adds the wording "so far as its powers extend".

The meeting moved into public session at 10:11am.

3. Chairperson's Business

3.1 Committee visit to Dublin

The Chairperson advised that along with 2 Committee Members, he had visited Dublin on Thursday 7 January 2016 where they: informally met with the Oireachtas Committee for Education and Social Protection; attended the BT Young Scientist Exhibition; and met with representatives of the Higher Education Authority and the Irish Universities Association.

Chris Hazzard joined the meeting at 10:15am.

Agreed: The Committee agreed to write to express its thanks to: the Oireachtas Committee for Education and Social Protection; BT; the Higher Education Authority and the Irish Universities Association.

Agreed: The Committee agreed to write to all of the Northern Ireland schools who submitted projects to the BT Young Scientist Exhibition in order to congratulate them and encourage their continuing involvement in this event.

Agreed: The Committee also agreed to seek clarification from the Department as to the financial and other support provided to schools in order to facilitate their participation in the BT Young Scientist Exhibition event.

Agreed: As part of its consideration of the promotion of STEM in schools, the Committee agreed that it would invite BT to make an oral presentation on the BT Young Scientist Exhibition event.

Agreed: Further to its consideration of the transferability of A-levels, the Committee agreed to write to the Department seeking an update on the numbers of A-level candidates successfully obtaining 3 or 4 A-levels including applied A-levels. The Committee also agreed to seek further information as to how the Department ensures that careers teachers are made aware of university and institute of technology places and scholarships etc. in the Republic of Ireland.

3.2 Budget 2016-17 - National Insurance

The Committee noted that the Department had advised Members, at its previous meeting, of a £30m pressure associated with changes to National Insurance.

Agreed: The Committee agreed to write to the Department seeking a breakdown of the pressure faced by each of its Arms Length Bodies in respect of National Insurance changes and an estimate of the impact of these changes on low paid workers employed in the education sector.

Agreed: The Committee agreed to write to the Department seeking an update on the budget position for special schools and the consideration it has given to the cost implications for the provisions of the Addressing Bullying in Schools Bill.

12.2 Oversubscription in school places in Lagan Valley constituency

Agreed: The Committee agreed to write to the Education Authority seeking clarification on the Area Planning action it is undertaking in order to address over-subscription in schools (and pre-schools) in Dromore, Kinallen and Dromora.
