**2. Promotion of STEM in Schools – Departmental briefing**

Dale Heaney, Head of Curriculum Development Team, Department of Education; Sam Dempster, Teacher Education Team, Department of Education; and Kim Scott, Assistant Senior Education Officer, South East Region, Education Authority briefed the Committee in respect of the promotion of Science, Technology, Engineering and Maths (STEM) in schools.

The Committee noted correspondence from the Council for the Curriculum, Examinations and Assessment (CCEA) in respect of the availability of STEM GCSEs.

The Committee also noted an invitation from the Assembly Education Service to attend a Science Festival for Key Stage 2 pupils, on Tuesday 15 February 2016, to celebrate National Science and Engineering Week.

### **3. SL1 Curriculum Complaints Tribunal – Departmental briefing**

Dale Heaney. Head of Curriculum Development Team, Department of Education briefed the Committee on the proposed rule entitled: The Complaints Tribunal (Curriculum and Related Matters) Regulations (Northern Ireland) 2016.

**Agreed:** The Committee agreed to write to the Department seeking clarification on the appropriateness of the wording used in the schedule of the regulation.

**Agreed:** The Committee agreed that it was content for the Department to make and lay the statutory rule.

**Agreed:** The Committee also agreed to forego an oral briefing on the rule when it is made and laid by the Department.

**Agreed:** Further to its consideration of STEM in schools, the Committee agreed to write to the Department seeking:

- information on the number of schools that use coding applications, such as Scratch;

- information on the number of schools providing the new GCE A-Level in Software Systems;
- a breakdown, by GCSE subject, of the 3.2% rise in STEM subject uptake in 2015-16;
- clarification on the provision of GCSEs in computing, previously offered by English examining bodies;
- an explanation as to how it encourages schools to avail of the STEM support and training which it has produced;
- information on the action being taken by Higher Education Institutions to incentivise the uptake of STEM subjects by pupils;
- information on the action it is taking to ensure that the curriculum matches the needs of the ICT industry;
- an update on how it is considering ways to measure pupil attainment other than by GCSE or A-Level performance; and
- confirmation that all schools have been made aware of the new progression routes for apprenticeships launched by the Department for Employment and Learning.

**Agreed:** The Committee agreed to write to the Department seeking clarity as to whether the e-portfolio is to be used to track and record non-academic pupil attainment.

**Agreed:** The Committee agreed to write to the Department expressing its concerns at the potential for duplication in administration and additional costs associated with different Early Years programmes and to seek the following:

- clarification as to how it plans to enhance governance and reduce administrative costs in those children's services for which it will have responsibility in the next mandate;
- sight of the essential/desirable criteria and the associated scoring matrix for the Pathway Fund;
- information on the number of children who benefited from the Early Years Fund;
- an estimate of the number of children likely to benefit under the Pathway Fund and approximate quanta of grant allocations;
- clarification as to how the Department proposes to deal with the mismatch between small areas of social disadvantage and super-output area designation; and
- clarification as to how it is to address gaps in the provision of Early Years places for pre-school children.
