2. Chairperson's Business

2.1 Tragic incident at Killowen Primary School

- information on the potential savings associated with cooperation within Area Learning Communities, including the Entitlement Framework;
- clarity on the cost savings to schools associated with previous teacher redundancy programmes;
- information on the phasing of Fresh Start capital expenditure; and
- an update on the funding and progress of the Strule campus project.

6. Special Schools Early Years provision - Strategic Leadership Forum for Special Schools and Parents' Equal Education Coalition
