The meeting commenced in closed session at 10:04am.

# 1. Committee inquiry into educational underachievement

The Committee discussed the terms of reference for its inquiry into educational underachievement.

Ms Carla Lockhart joined the meeting at 10:08am.

Mr Philip Logan joined the meeting at 10:15am.

**Agreed:** The Committee agreed the terms of reference for its inquiry into educational underachievement as follows.

"The Committee will:

- Review the nature of educational underachievement by school pupils in primary and post-primary schools including a focus on the experience and progress of marginalised groups;
- Identify the key barriers to, and enablers for, educational achievement by school pupils including a focus on: early years interventions, literacy and numeracy programmes and the impact of academic selection and post-primary transfer;
- Identify and analyse alternative approaches and models of good practice in other jurisdictions in terms of policy interventions and programmes;
- Consider what priorities and actions need to be taken in order to improve educational achievement by school pupils – particularly for marginalised groups including e.g. Looked After Children - and including the effectiveness of the Departmental policies such as Count, Read, Succeed and relevant interventions; and
- Report to the Assembly on its findings and recommendations by Christmas 2017."

**Agreed:** The Committee agreed to issue a call for evidence which would close in February 2017. The Committee also agreed to seek inquiry evidence from the Children's Law Centre youth panel.

**Agreed:** The Committee further agreed to publicise the terms of reference: on its webpage, through social media and using newspaper advertisements, as appropriate. The Committee also agreed to give further consideration to publicising the inquiry in order to enhance stakeholder engagement.

The Committee moved to open session at 10:23am.

#### 2. Forward Work Programme

**Agreed:** The Committee agreed to undertake training in effective questioning expected to be scheduled in January 2017 at a venue outside of Parliament Buildings.

**Agreed:** As Members are unable to attend a PTA-NI event on 30 November 2016, the Committee agreed to invite PTA-NI to brief the Committee informally.

**Agreed:** The Committee agreed to attend a coding in schools event at Stranmillis University College on Wednesday 7 December 2016, subject to further consideration of the relevant timings.

**Agreed:** The Committee agreed to reschedule its Children's and Young People's Strategy stakeholder event from Wednesday 7 December 2016 to a later date in the new year.

**Agreed:** The Committee agreed its press plan for Anti-Bullying Week including the agreement by email of a related Committee press release.

**Agreed:** The Committee also agreed to write to the Department of Education and the Department of Health seeking an update on measures to support the home childcare scheme and clarification:

- as to the ineligibility of the scheme for VAT exemption;
- in respect of the suggested legislative timescales; and
- as to the impact of the introduction of the new tax free childcare scheme.

# 9. Department of Education - 2016-21 Programme for Government (PfG) Departmental Draft Delivery Plans - Consultation

**Agreed:** The Committee agreed to forward to the Department a summary table of the educational aspects of the PfG Delivery Plans and seek confirmation in respect of relevant targets etc.. The Committee also agreed write to the Department seeking:

- an update on the participation in shared education by schools;
- clarification in respect of rural proofing of Area Planning proposals
- clarification as to whether the new "dashboard of measures", agreed statement on what is valued in education and methodology relating to the evaluation of education/school quality will involve changes to the Every School a Good School policy;

- an explanation as to why the PfG Indicator 9 refers to sharing in e.g. leisure centres and libraries but does not refer to schools; and
- an explanation as to why the PfG draft Delivery Plans do not include an Indicator in respect of the promotion of shared and integrated education.

**Agreed:** The Committee also agreed to seek an oral evidence session from the Education Authority (and Department, if appropriate) on the reported rationalisation of Outdoor Activity Education Centres.

**Agreed:** The Committee agreed to write to the Education Authority seeking clarification in respect of the number of pre-school Special School places required and confirmation that all Special School principals (including those from schools whose pre-school hours had been reduced) had been invited to participate in the Education Professional Practitioners Consultative Group.

**Agreed**: The Committee agreed to arrange a related stakeholder event in February 2017.
