#### Dear Cathie

I refer to the Committee's e-mail of 17th October 2013, regarding the audit of further education (FE) college provision for Post-19 Special Educational Needs (SEN) students. The Department has provided the following response to the questions, raised by the Committee.

The post-19 SEN audit of provision was conducted in April/May 2013 and was based upon information provided by colleges for the 2012/13 academic year. However, validated statistical information for the 2012/13 academic year will not be available until December 2013; therefore, the Department has provided a response to the Committee, based upon data for the 2011/12 academic year, which is the latest academic year for which information is available. The Department will forward a response to the Committee, based upon 2012/13 data, when this information is published.

### (i) A detailed breakdown of courses (by subject) for those with learning difficulties

I can advise there are 15 key subject areas, provided by FE colleges, for those with learning difficulties and/or disabilities; these subject areas are provided below:

Health, Public Services & Care Science & Mathematics Agriculture, Horticulture & Animal Care Engineering & Manufacturing Technologies



Construction, Planning & the Built Environment Information & Communication Technology Retail & Commercial Enterprise Leisure, Travel & Tourism Arts, Media & Publishing History, Philosophy & Theology Social Sciences Languages, Literature & Culture Education & Training Preparation for Life & Work Business, Administration & Law.

Within each of these subject areas there are many variations in courses and qualifications (a sample of the type of courses has been provided at **Appendix A**).

# (ii) The percentage of those individuals with learning difficulties, who are attending colleges and who are completing courses to level 2.

During the 2011/12 academic year, 40% of students, declaring learning difficulties and/or disabilities, were enrolled on Level 2 mainstream courses and 7.5% of those enrolled in discrete programmes were participating in a Level 2 course.

Discrete programmes are specifically designed for students with moderate to severe learning difficulties/disabilities, for whom mainstream FE provision is not appropriate.

## (iii) An assessment of the overall colleges' use of the Additional Support Fund.

I can advise that colleges are committed to being inclusive and widening access to further education for those young people with learning difficulties and/or disabilities. Since the introduction of the Additional Support Fund in 1998, there has been an increase in Departmental funding from £300,000 per annum to £4 million per annum. This reflects the continued increase in the number of enrolments of students with a learning difficulty and/or disability. In the 2004/05 academic year there were 13,205 students declaring a disability, which equated to 5% of total enrolments, whereas in 2011/12 (most recent available statistics) this had increased to 22,710 students declaring a disability, which equated to over 12% of total enrolments.

The Fund's aim is to help FE colleges deliver courses and provide individual support and assistance to these young people. The fund provides £2 million for the provision of additional individual technical and personal support and a further

£2 million to provide tailored courses, including smaller class sizes and classroom assistants, for those unable to participate in mainstream courses, due to the nature/degree of their disability/learning difficulty.

In the past, as a result of a continued increase in numbers requiring additional support, many colleges overspent on their individual allocations and the Department, in turn, met these overspends. On occasion, colleges had to restrict the level of support given to some students to ensure as many students as possible, needing support, could receive it. This was a major driving factor in the Department's recent decision to increase the money available to colleges under the Additional Support Fund. That increase in funding aims to ensure that the level of support provided by colleges is reflective of the numbers of eligible students and the level of support needed.

The Department has introduced additional arrangements to monitor the number of students receiving personal and technical assistance through the ASF, to allow the Department to assess the effectiveness of the additional funding.
