## 2. Draft Minutes of Meeting of 3<sup>rd</sup> November 2015

Agreed: the Committee agreed the draft minutes of 3<sup>rd</sup> November 2015.

# 4. Legislation: Credit Unions and Co-operative and Community Benefit Societies Bill

Members noted papers in relation to the Credit Unions and Co-operative and Community Benefit Societies Bill.

# 5. Oral Briefing from DETI: Consultation on the Closure of the Northern Ireland Renewables Obligation (NIRO) to New Onshore Wind

The officials joined the meeting at 10:18am

Members received a briefing from Mr Chris Stewart, Head of Policy Group, DETI, Mr John Mills, Head of Energy Division, DETI, Ms Alison Clydesdale, Principal Officer, Renewable Electricity Branch, DETI and Mr Michael Harris, Deputy Principal, DETI.

The key issues discussed were an update from the Minister on the consultation, correspondence between the Minister and the Secretary of State for Energy and Climate Change, the effect of uncertainty for businesses and the effect on small scale developers.

The officials agreed to explore with the Department for Energy and Climate Change (DECC) amended legislation to accommodate those projects which are currently awaiting consent and which will be affected by the 'cut off' date. As provision has been made for those projects which are currently in planning appeal, the officials also agreed to clarify the position for those projects which once planning has been approved may still be awaiting consent for connection.

The officials also agreed to forward to the Committee an estimation of the potential amount of investment that is at risk due to uncertainty for businesses around this matter.

Agreed: to write to the Secretary of State for Energy and Climate Change to request a joint meeting with the Energy Secretary and the Minister.

*Agreed:* to ask that the Department to forward to the Committee copies of all of the correspondence between the Energy Secretary and the Minister on the matter.

Agreed: to ask the Department for the dates and details of all of the meetings and conversations between the Minister and the Energy Secretary on the matter.

#### 11. Announcement to Close Michelin, Ballymena

Members discussed the recent meetings with Unite and the Minister on the closure of the Michelin plant in Ballymena.

The Chairperson reminded members that the Committee asked Unite for any information it may have on whether or not Michelin was provided with assistance or incentives to create additional jobs in its Dundee and Stoke facilities.

The Chairperson also reminded members that the Minister had agreed to check if the investment in Stoke and Dundee was in car or truck tyre production, provide any suggestions or proposals on how logistics can be improved, and reflect on the capacity to use the EU Globalisation Fund to support employees.

Agreed: to await the response from the Minister to the issues raised.

# 12. Written Briefing from the Irish Economic & Social Research Institute: Scoping the Possible Economic Implications of Brexit on Ireland

Members discussed a report by the Irish Economic & Social Research Institute entitled Scoping the Possible Economic Implications of Brexit on Ireland.

Agreed: to forward the report to the Department and the Systems Operator for Northern Ireland (SONI) and ask for their assessment of the energy aspects of the report, especially in relation to the suggestion that Northern Ireland relies on electricity imports from the Republic of Ireland to make up for insufficient local electricity generation capacity.

*Agreed:* the Committee agreed the Forward Work Programme.
