## 1. Apologies

#### 3. Draft Minutes

The minutes from the meeting of 21<sup>st</sup> November 2013 were agreed subject to minor amendments.

#### 4. Matters Arising

4.1 The Committee considered a Departmental letter regarding the salary determination for new Council Chief Executive posts.

Agreed: The Committee agreed to write to the Department to ask for further information as to how the Council interviews are to be scheduled for candidates

The Committee went into closed session at 1:19pm to consider the draft Committee report on the Carrier Bags Bill.

## 5. Consideration of the draft Committee report on the Carrier Bags Bill

# 6. Departmental briefing on the taxis reform programme and synopsis of responses to the consultation on taxi driver testing

Ian Greenway (Principal Officer, Road Safety & Vehicle Regulation Division), Alex Boyle (Road Safety & Vehicle Registration Division) and Michael O'Neill (Taxis Act Implementation Team) briefed the Committee on the taxi reform programme and the synopsis of responses to the consultation on taxi driver testing.

The main areas discussed were the cost implications of testing for taxi drivers, the time required to carry out testing and the rationale for the testing of existing drivers.
