2. Chairs Business

The Chairperson reminded members that the Committee would be participating in a panel discussion following its meeting on Thursday 18 June at the NILGA conference.

The Committee noted an invitation from Northern Ireland Environment Link to a Seminar on Engaging Heritage with Community Planning.
