The meeting opened at 10.05am in public session.

#### 1. Apologies

*Agreed:* that agenda item 4 and 5 are covered by Hansard and the Official Record published on the Assembly's website.

# 2. Draft Minutes of Proceedings of 15 May 2013

## 3. Matters Arising

Table of Requests for Information from the Department of Finance and Personnel (DFP)

The Committee noted the table of requests for information from DFP which provided an update on any matters arising not covered elsewhere on the agenda.

## Marriage (Same Sex Couples) Bill

The Committee noted that the proposed Legislative Consent Motion was not considered by the Executive at last week's meeting.

*Agreed:* that the Committee would proceed with oral briefings at next week's meeting from Assembly Research and from the Department of Finance and Personnel on the proposed Legislative Consent Motion. It was also agreed that the Assembly research would include an examination of any differences between civil partnerships and same-sex marriages.

### Defamation Bill

Mr Cree indicated that Mr Mike Nesbitt MLA would be content to brief the Committee on his Private Members' Bill on this matter.

#### 4. Public Service Pensions Bill: Proposals on way forward – DFP evidence session

*Agreed:* to share the DFP papers for this evidence session with the trade union representatives in advance of the next session.

Mr Weir joined the meeting at 10.12am. Mr McCallister joined the meeting at 10.16am. Mr McQuillan joined the meeting at 10.45am. Mr Weir left the meeting at 10.46am. Ms Fearon left the meeting at 10.49am. Mr Weir joined the meeting at 10.54am.

The Committee received a briefing on proposals on the way forward in relation to the Public Service Pensions Bill from the following DFP officials: Grace Nesbitt, Head of Pensions Division; Blathnaid Smyth, Pensions Division, Corporate Human Resources (CHR); and Margaret Coyle, Pensions Division, CHR. The session was recorded by Hansard.

*Agreed:* that the DFP officials would provide follow up information in relation to issues raised during the evidence session.

The Committee noted that other relevant statutory committees have been notified of the impending Committee Stage of this Bill and subsequent secondary legislation and that the Committee for Finance and Personnel would be seeking their views in due course.

#### 6. Public Service Pensions Bill – Trade Union evidence session

*Agreed:* that the trade unions will provide the Committee with a copy of the correspondence they received from the Equality Commission regarding the proposed Bill.

*Agreed*: that written submissions on the proposed Bill are sought, at this stage, from the Equality Commission and the Northern Ireland Human Rights Commission.

*Agreed:* that the Committee will review the issues raised in today's evidence sessions and identify which matters require further examination and responses from the Department.

The Committee noted correspondence from the Committee for Employment and Learning which indicated contentment that the Finance and Personnel Committee carries out the scrutiny on this proposed Statutory Rule.

*Agreed*: that the Committee has considered DFP's proposal for subordinate legislation under The Statistics and Registration Services Act 2007 (Disclosure of Higher Education Student Information) Regulations (NI) 2013 has no objection to the policy implications of the proposed legislation at this stage. The Statistics and Registration Services Act 2007 (Disclosure of Pupil Information) Regulations (NI) 2013.
