7. SL1 The Draft Caseins and Caseinates Regulations (Northern Ireland) 2016

The Committee considered a proposal for a statutory rule to transpose and provide penalties for non-compliance with the requirements of EU Directive 2015/2203 which provides for the approximation of the laws of the Member States relating to certain lactoproteins (caseins and caseinates) intended for human consumption.

Agreed: The Committee agreed that it was content that the Department make

the statutory rule.

8. Correspondence

i. The Committee considered an invitation from Policy Forum NI for the Chair to deliver a keynote address at a Mental Health Seminar on 17 January 2017.

The Committee considered correspondence from the Royal National Institute of Blind People promoting the adoption of an 'accessible information standard' by Healthcare providers to address the difficulties of people with sight loss receiving information about their own health and care which they are unable to read.

Agreed: The Committee agreed to write to the Department of Health to enquire about the adoption of the 'accessible information standard'.

v. The Committee considered correspondence from the Committee for the Executive Office seeking the Committee's views on its European priorities for the year ahead as part of its work on compiling the 2017 report on Assembly Committee European Priorities.

x. The Committee considered an invitation from the Belfast Health and Social Care Trust to visit a facility in which people with dementia are living in an independent residence.

Agreed: The Committee agreed to consider the invitation at its strategic planning meeting in the new year.

- xi. The Committee noted the Department of Health's Diabetes Strategic Framework and Implementation Plan which was published on 22 November 2016.
- xii. The Committee noted correspondence from the Committee for Justice regarding its review of the need for stalking legislation.
- xiii. The Committee noted the Criminal Justice Inspection NI report on an unannounced visit to Maghaberry Prison to review progress against the nine inspection recommendations made in 2015.
- xiv. The Committee noted a copy of correspondence from the Department of Health to the Assembly Business Office withdrawing the Legislative Consent Memorandum relating to the Health Service Medical Supplies (Costs) Bill which was laid on 1 November 2016; and considered the revised LCM relating to the Health Service Medical Supplies (Costs) Bill that was laid on 22 November 2016.
