The meeting began in closed session at 2.03 pm.

1. Inquiry into Building a United Community

The Committee considered a confidential paper outlining areas for potential recommendations on the Inquiry into Building a United Community.

Agreed: The Committee agreed to bring the paper back for a fuller

discussion at next week's meeting.

Chairs' Forum

The Committee noted an invitation from the Chairs' Forum to a breakfast briefing on the Northern Ireland Economic Outlook which is to be held on Wednesday 27 May 2015 in the Waterfront Plaza, Belfast.

Historical Institutional Abuse Public Lecture

The Committee noted an invitation to a public lecture by Professor Kathleen Daly on "What is required for effective redress for historical institutional abuse" which is to be held at the Ulster University Belfast campus on Monday 15 June 2015.

Members also noted the recent announcement by the Historical Institutional Abuse Inquiry to add three institutions to the scope of the Inquiry, along with issues arising from the actions of Father Brendan Smyth in so far as these relate to the Inquiry's Terms of Reference.

Agreed:

The Committee agreed to write to the Department noting the extension to the number of modules to be undertaken by the Historical Institutional Abuse Inquiry, and its continued concern for those victims who fall outside the scope of the current Inquiry terms of reference; and to advise of the Committee's intention to raise this matter during the forthcoming briefing with the First Minister and deputy First Minister.

Agreed:

The Committee agreed to write to Sir Anthony Hart to seek further information on the addition of the three institutions to the Inquiry, and clarification on the specific area of inquiry with regard to Father Brendan Smyth; and to seek assurance that these additions will not impact negatively on the timescale of the Inquiry, and associated costs.
