ANSWER

Network Personnel deliver the Local Employment Intermediary Service (LEMIS) in the Moyle District Council area and the wider outreach NI Area 2 for clients with a common employability barrier. The table at Annex A provides a breakdown of the number of caseloads and the number of clients who entered employment by electoral areas, since the service began in September 2011.



There are currently 50 active clients; however, the flexible nature of LEMIS allows clients to disengage and re-engage whenever they wish to receive help and support. LEMIS clients can use the service on a voluntary basis at any time that suits them and this will not affect any benefits they may receive.
