**Ref: AQW 8367/17-22**

I refer to your question AQW 8367/22-17, in which you asked me to detail each occasion I formally agreed that the Westminster government would introduce a statutory instrument since taking up office.

I regret to advise that the original response to your question contained some errors. The dates I agreed to the Blood Safety and Quality (Amendment) (EU Exit) Regulations 2020, the Quality and Safety of Organs Intended for Transplantation (Amendment) (EU Exit) Regulations 2020 and the Human Tissue (Quality and Safety for Human Application) (Amendment) (EU Exit) Regulations 2020 was 5 October 2020, not 23 September 2020.

A revised answer to AQW 8367/17-22 is appended, providing the correct dates. I have also copied this letter to the Assembly library.
