#### AQW 18839/17-22 INFORMATION TO BE PLACED IN THE ASSEMBLY LIBRARY

Due to the volume of detail provided by the Housing Executive in answer to AQW 18839/17-22, the information attached at Annex A has been placed in the Assembly Library.

As per AQW 17715/17-22, the Housing Executive provided a breakdown of the number of housing applications that had been cancelled from the social housing Waiting List in the last 5 years, presented by the reason which was recorded on the Housing Executive's Housing Management System. The tables below provide an additional breakdown of those reasons by year and by Housing Executive Area locations.

Due to this being historic data, the Housing District outlined is that of the owning office (i.e. the office to which the applicant made their housing application) rather than the location that the applicant wished to be re-housed in.

In 2016 / 2017 the Housing Executive restructured its reporting geographies to ensure that its reporting was coterminous with Local Government Districts. This resulted in its Belfast offices being amalgamated into one 'Belfast Area'. The Belfast data in this report therefore reflects the composite Belfast Area.

It should also be noted that there were 74 cases incorrectly recorded against housing associations and so cannot be attributed to a Housing Executive Housing Area. These have been grouped under 'Housing Associations'.

The following notes were included in the original request and are still applicable to this

dataset:

A number of applicants are 'temporarily' removed from the waiting list for a

period of a time following a 'Deferral' in line with policies and procedures and

the statutory rules of the Housing Selection Scheme. Once the deferral period

has expired these cases are automatically added back on to the Waiting List.

Those cases are not included in this table.

• A number of cases have been identified as having an incorrect cancellation

reasons and are included in the final row of the table under 'Incompatible

Code'. These cases are currently being investigated.

Some applicants who are removed from the Waiting List may subsequently

re-apply for social housing at a later date and are therefore re-included on the

Waiting List.

Following the first lockdown in March 2020, changes were made to the

Waiting List annual renewals process and procedures to accommodate the

COVID-19 restrictions. These changes were in place throughout 2020/2021

and may have resulted in a number of applicants being retained on the

Waiting List who would otherwise have been removed as a result of the No

Reply to Renewal Reminder process under normal operational activity.
