ANSWER

The potential impact of an expert led, independent Infrastructure Commission on

capital infrastructure projects within my department would very much depend on the

detail of any such proposal.

I am reassured to note that my department already possesses a great deal of

expertise in its delivery of major infrastructure schemes and is working

collaboratively with other departments and the Strategic Investment Board in

preparation for the agreement of an Investment Strategy.

This Strategy will determine the capital projects my department will take forward over

the next ten years, and will include a range of 12 enabling actions designed to

improve our ability to plan for, procure and deliver these schemes.

These actions include Capability Planning, improvements to our Business Case

Process; enhanced Monitoring and Assurance; an Infrastructure Needs Assessment

and Carbon Assessments and Standards.

As an outworking of DAO 02/20 - Revised Guidance on Best Practice on Project

Delivery and Engagement with the Gateway/Assurance Review Process, my

Department has an established P3O Office and Major Projects Committee to provide

the required oversight of these infrastructure projects.
