






Growth of ZHCs, UK (Source: ONS)

In employment on a zero hours contract (thousands)












Awareness of ZHCs: Google Trends

Searches for 'zero hours contracts' (index form, peak=100)












Which came first? ZHCs or media?












Who are the ZHC workers?

per cent of those in employment who are on a zero hours contract (Source: ONS)












Who are the ZHC workers?

per cent of those in employment who are on a zero hours contract (Source: ONS)












Who are the ZHC workers?

Per cent of people in employment who are on a zero hours contract (Source: ONS)












Which industries use ZHCs most?

ZHCs and wages

- Recent Resolution Foundation research for the UK shows:
 - ZHC workers earn 38% less per hour than permanent employees
 - Four fifths of this gap is explained by factors such as age, gender, experience, education, occupation, industry and tenure
 - But one fifth of this gap 6.6 per cent, or 93p per hour – is not explained by these factors
 - For a typical ZHC worker, working 21 hours per week, this wage penalty amounts to £1000 per year









ZHCs and job satisfaction

- Do ZHC workers trade-off lower pay and job insecurity for greater flexibility or a foot on the ladder?
- If so we'd expect ZHC workers to be no less satisfied in their jobs than other (similar) workers
- Internationally, research evidence suggests workers in casual-type jobs are less happy with their jobs
- UK studies also suggest workers in casual and seasonal jobs report lower levels of job satisfaction
- The only published estimate of job satisfaction for ZHC workers vs. others suggests no difference (CIPD 2013)









Conclusions

- These questions about ZHCs matter for employers, for workers, for government
- In particular consider draft PfG Outcome 6 (More and Better Jobs) and the proposed "Better Jobs Index"
- Bottom line: we know enough about ZHCs to know that we don't know enough about ZHCs
- How to move forward in NI?
 - Can we make better use of existing data?
 - Can we add question(s) about ZHCs and other non-standard job types to existing surveys?
 - Can we learn more about the quality of ZHC jobs and their impacts on workers (to build an evidence base)?
