

## **2010 EUROPEAN YEAR FOR COMBATING POVERTY AND SOCIAL EXCLUSION**

### **In Brief**

2010 is the *European Year for Combating Poverty and Social Exclusion* (EY2010). Member States have organised activities at national, regional and local levels to increase public awareness of poverty and social exclusion, how it affects people and societies, and how it can be eliminated.

The EU has provided a budget of €17 million which should rise to €26 million through contributions from Member States and other sponsors. The UK budget for the *Year* is approximately £1.2 million. The Department for Work and Pensions (DWP) is responsible for coordinating the *Year* in the UK. Each of the UK devolved regions is running events.

### **Why a “European Year”?**

The first *European Year* was established in 1983. In nearly every year since then the EU has chosen a priority theme with the aim of raising public awareness of that specific issue.

2010 is a significant date. It marks the 10th anniversary of the Lisbon Council which made a commitment to make a decisive impact on the eradication of poverty by 2010. However, this objective is far from being met - it is estimated that 16% of the European Union's population - 79 million people live below the poverty line.

### **What does the Year hope to achieve?**

Fighting poverty and social exclusion is vital to the EU's goals of improving social cohesion, achieving economic growth and improving employment opportunities. With the sharp rise in unemployment that many countries are facing, there are more people than ever at risk of falling into poverty, so the *Year* takes place at a significant point in time.

In designating this *European Year* the EU aims to reaffirm the importance of collective responsibility in combating poverty, bring together people working in this area and give a voice to those who are experiencing poverty and social exclusion.

### **What will be happening?**

The 27 EU countries as well as Norway and Iceland are taking part. A variety of activities are planned at EU, and at national, regional and local level in Member States. These include meetings, discussions and conferences, awareness campaigns, innovative schemes to promote social inclusion, and competitions highlighting success stories.

### **How was funding obtained?**

#### Regional activities:

Each of the nine Government Office Regions of England and each of the devolved administrations were invited by DWP to submit proposals for regional activities. A maximum budget of £30,000 was available for any regional activity.

#### Thematic programmes:

Proposals were also sought in respect of the delivery of four UK-wide programmes of activity that would be delivered at a local or grassroots level. The activity had to be aligned to one of the Year's key thematic challenges – child poverty, severe multiple deprivation and those at most risk of social exclusion, working age adults (that is, overcoming barriers to participation in the labour market) and Older People and poverty or social exclusion. A maximum of £125,000 was available for each of these thematic programmes.

### **What is the UK doing?**

- The UK is running a mixed programme of local and national activities which aim to:
  - Involve people experiencing poverty and/or those experiencing social exclusion
  - Include workshops, seminars, focus groups for people who use services to see what's working and what's not
  - Bring together people experiencing poverty and the policy makers
  - Give a voice to children and young people
- The UK launch for the European Year will be held in Bristol on 16 March<sup>1</sup>.
- A key UK event will be the Eurocities in-depth review seminar on child poverty in September. This two day international conference will bring together practitioners, academics, experts, and key stakeholders to improve knowledge, skills and insights into the problems and solutions of child poverty. The particular themes will be; the contribution of cities; the roles of local partners and the role of national and international leadership legislation and resources in tackling the child poverty challenge<sup>2</sup>.

### What is Northern Ireland doing?

- As part of the *European Year*, CSV Media are hosting a talk in Belfast on the theme of combating poverty on Monday 1 March. The speakers are Richard Wilkinson (co-author of *The Spirit Level*), Paddy Hilliard and Gerry Mulligan (OFMDFM)<sup>3</sup>.
- The Northern Ireland launch of the *European Year* will be held on 24 March in Belfast City Hall. This event aims to showcase the work taking place at both a local and regional level to tackle social exclusion and seeks to raise awareness of the initiatives currently in place to tackle poverty and social exclusion. It is anticipated that around 200 people will attend the event.
- Save the Children Northern Ireland has won its bid for funding of a regional 2010 European Year activity. The project will involve participatory research with family members and young people with findings feeding into a conference designed to engage policymakers and decision-makers. Outcomes will constitute a *World Apart* exhibition touring Northern Ireland during the autumn. Over 100 people will be directly involved, many of them children.<sup>4</sup>
- Save the Children has also been successful in winning its bid for funding of a thematic 2010 European Year programme of activity: *Speaking Out Against Poverty* (SOAP). Save the Children alongside partner organisations will deliver a series of workshops to build understanding of poverty and its effects on young people and their communities. These communities in Belfast, Derry and Dungannon will be among the poorest in our society and dealing with issues such as high unemployment, health issues, poor educational attainment and debt. Young people will take part in a series of community based initiatives to tackle these poverty related issues, they shall record evidence of poverty and demonstrate opportunities to improve their community and shall challenge decision makers at local and national level to take action to eradicate poverty by 2010.

### What's happening in Scotland?

- For the *European Year* the Poverty Alliance is running a series of 10 seminars entitled "*Fighting Poverty in Scotland – Achievements and Possibilities*" throughout Scotland starting in March with the aim of raising the profile of the debate about how best to tackle poverty.
- A key event for the *Year* is a conference; "*Tackling Poverty and Social Exclusion in Europe through education for Democratic citizenship /Human Rights education*" in Glasgow on 3 and 4 March. The program consists of country reports and case studies from all over Europe to highlight the effects of poverty and social exclusion for democratic citizenship and human rights education – and vice versa.

## What's happening in Wales?

- Actions taken by the Assembly Government, the executive body of the National Assembly for Wales, to raise the profile of the *European Year* include:
  - Making information about the *Year* available through the Assembly Government's website
  - Making information available to Assembly Government departments and asking them to circulate it to relevant stakeholders
  - Liaising with stakeholders such as the End Poverty Network, the Welsh Local government Association, the Anti-Poverty Network Cymru and Children in Wales
  - Advertising calls for proposals
  - A news page article to Assembly Government staff to raise awareness internally
  
- Towards the end of 2009 the European and External Affairs Committee in the National Assembly for Wales carried out a short inquiry into the European Year for Combating Poverty and Social Exclusion<sup>5</sup>. The Terms of Reference for the inquiry were:
  - To understand the relevance to Wales of the 2010 European Year for Combating Poverty and Social Exclusion
  - To ascertain how the Welsh Government proposes to engage with the *European Year* including its involvement in the UK National Implementing body, details of any events or campaigns it proposes to organise and any additional funding it proposes to make available to the third sector to support activities across Wales during the *Year*.
  - To understand what ( if any) strategy the Welsh Government has towards "European Years" in general, to ensure Wales is engaging as effectively as possible for the opportunities these present
  - To explore how the National Assembly for Wales can support initiatives such as the 2010 European Year and future European Years
  - To hear from Welsh and European Stakeholders about how best practice is being shared and the actions they have planned to maximise the opportunities presented by the 2010 European Year.

The main emerging issues from the inquiry were:

- The overarching aim of EY2010 is to raise awareness of poverty and social exclusion
- It's an opportunity for exchange of best practice at EU and international level

- Third sector and organisations and networks are the primary target of the European Year
  - Child poverty and child well being are areas in need of attention during EY2010, including calls for more concerted action on these issues at EU level
  - EY2010 can be part of a wider lobbying strategy to create a “lasting political legacy”
  - It is an opportunity to clarify how Wales compares on EU-wide common indicators of poverty, both in an “absolute” sense and in terms of the “relative measures” of poverty
- A key event in Wales EY2010 programme will be “*Tackling poverty and social exclusion in Wales*”, a conference to encourage the exchange of solutions to poverty, and to give a voice to those most affected. The Bevan Foundation, a Welsh think-tank and research charity is organising the event.

### **What’s happening in the Republic of Ireland** <sup>6</sup>

- Minister Mary Hannifin TD launched the Irish programme for *EY 2010* on 5<sup>th</sup> February 2010. The programme involves a range of events and activities throughout the country organised by Government departments, and agencies, local authorities, expert organisations, social partners, and national and local and community organisations:
  - Regional seminars covering topics including child poverty, access to quality work and learning opportunities, access to services for older people and people with disabilities
  - Workshops to explore specific themes reflecting the ‘communities’ dimension of the National Action Plan for social Inclusion. Topics include groups who are marginalised in society, urban and rural disadvantage, migration and traveller issues.
  - Two social inclusion weeks in May and October to highlight best practice and showcase locally-based social inclusion initiatives and activities.
  - Other events throughout the country to promote awareness of poverty and social inclusion. These include one-off events and initiatives, organised by groups in the community and voluntary sector, the statutory sector, and sporting and cultural organisations.
- A key event is the European Anti-Poverty Network (EAPN) International Conference in Dublin on 19<sup>th</sup> February entitled “*Building Social Europe – From Crisis to Opportunity*”. <sup>7</sup>
