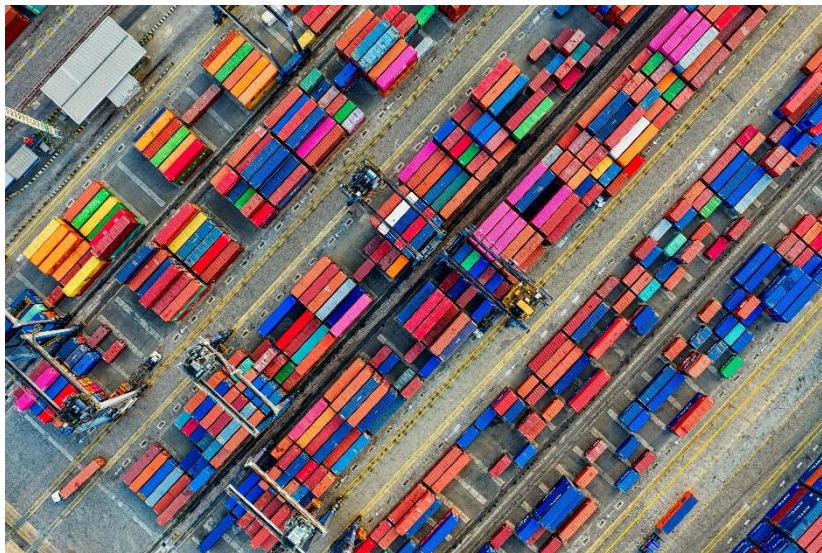

1. INTRODUCTION

This reading list – ‘Brexit Outcomes and Northern Ireland’ – was created to assist Members of the Legislative Assembly (MLAs) and others to contemplate developments following the UK’s formal exit from the European Union on 31 January 2020.

Of most relevance to this latest edition is the fact that the Northern Ireland Assembly is now set to hold a crucial democratic consent vote determining whether Articles 5 to 10 of the Windsor Framework will continue to apply in Northern Ireland.

If the motion were to receive cross-community consent where a majority of both unionist and nationalist MLAs support the motion then it would not return to the Assembly for another eight years.

In the event that consent is granted through a simple majority vote, the UK Government will commission an independent review to evaluate the functionality of the Protocol and Windsor Framework, as well as the potential implications of maintaining or terminating alignment on various aspects of Northern Ireland, including social, economic, and political dimensions.

Should the democratic consent motion be rejected by MLAs, starting from 1 January 2027, Northern Ireland would no longer be part of the EU’s customs territory and internal market for goods.

When compiling this reading list, an attempt has been made to select commentary, analysis and media coverage which has particular relevance to these developments, as well as to wider material as long as the focus is the specific context of Northern Ireland. The list also includes strategically important documents, such as the published positions of the UK and Irish governments and the EU institutions.

As the volume of published material on Brexit is vast and varied, this reading list does not purport to be a single comprehensive source covering all issues and opinions. However, the material has been drawn from a wide range of well-established and authoritative sources and RalSe intends to update the reading list as appropriate.
