# European Commission Work Programme 2025 'New' and 'Replacement' EU Acts

This paper seeks to inform the work of the Windsor Framework Democratic Scrutiny Committee by identifying those initiatives or proposals in the European Commission work programme 2025 which are potentially either 'replacement acts' or 'new acts' under the Windsor Framework.

This information is provided to Members of the Legislative Assembly (MLAs) in support of their duties, and is not intended to address the specific circumstances of any particular individual. It should not be relied upon as professional legal advice, or as a substitute for it.

#### Introduction

On 12 February 2025, European Commission (the Commission) published its work programme for 2025 (CWP 2025)<sup>1</sup> which outlines the key legislative and policy actions it plans to take in the upcoming year.

The CWP 2025 is the first work programme of the second mandate of President von der Leyen, and its contents are shaped by seven policy priorities:

- 1. A new plan for Europe's sustainable prosperity and competitiveness
- 2. A new era for European defence and security
- 3. Supporting people, strengthening our societies, and our social model
- 4. Sustaining our quality of life: farming, food security, water, and nature
- 5. Protecting our democracy, upholding our values
- 6. A global Europe: leveraging our power and partnerships
- 7. Delivering together and preparing our union for the future.

The Commission presented the work programme in the form of a communication entitled 'Moving forward together: A Bolder, Simpler, Faster Union', accompanied by five annexes providing greater detail on the Commission's legislative and non-legislative intentions for 2025.

Whilst the legislative initiatives derived from the CWP 2025 are not applicable to the UK as a whole anymore, under the provisions of the UK-EU Withdrawal Agreement, including the Windsor Framework<sup>2</sup>, legislative initiatives and proposals may have implications for Northern Ireland.

Under Article 13(3) of the Windsor Framework, if the EU amends or replaces EU legislation listed in the Annexes of the Windsor Framework (formerly Ireland/Northern Ireland Protocol), Northern Ireland must dynamically align with these changes. Under Article 13(3)(a), which provides for the "Stormont Brake", MLA's have the opportunity to formally object to dynamic alignment with an

updated EU law in Northern Ireland<sup>3</sup>. The final decision to prevent the application of an updated EU law, however, rests with the UK Government.

Under Article 13(4), a new EU act that falls within the scope of the Windsor Framework but which neither amends or replaces an EU act listed in the Annexes, can be added to the Annexes with the agreement of the EU-UK Joint Committee. Before the UK Government can agree with the EU in the Joint Committee, however, the Northern Ireland Assembly must provide cross-community support for the new law to be added to the Framework by passing an 'applicability motion'.<sup>4</sup>

The Windsor Framework Democratic Scrutiny Committee (DSC) was established to assist with the observation and implementation of Article 13(3)(a) and Article 13(4) of the Windsor Framework. The DSC's functions include:

- examining and considering new EU acts and replacement EU acts;
- conducting inquiries and publishing reports in relation to replacement EU acts;
- engaging with businesses, civil society and others in relation to replacement EU acts;
- engaging with the UK Government in relation to replacement EU acts;
- engaging with Ministers of Northern Ireland departments and the NI Executive in relation to replacement EU acts;
- dealing with other matters (including legislative proposals which may become new EU acts or replacement EU acts) which the Committee considers to be connected with its purpose or other functions.

This paper seeks to inform the work of the DSC by identifying those initiatives and proposals in the CWP 2025 which are potentially either 'replacement EU

acts' (which might be subject to the 'Stormont Brake') or 'new EU acts' (which would be subject to an applicability motion).

# 1 Commission Work Programme Analysis

This paper is organised to reflect the structure of the Commission's work programme.

The CWP 2025 outlines fifty-one new initiatives listed in Annex I, along with one hundred and twenty-three pending EU proposals detailed in Annex III. Annex II highlights thirty-seven evaluations and fitness checks of legislation the Commission plans to conduct this year. Meanwhile, Annexes IV and V of CWP 2025 contain EU legislation that the Commission intends to withdraw (thirty-seven directives, regulations or decisions) or repeal (4 regulations or decisions), respectively.

Analysis of the CWP 2025 was undertaken to identify potential 'replacement' or 'new' legislative acts, as defined in The Windsor Framework (Democratic Scrutiny) Regulations 2024.<sup>5</sup> These regulations specify that, in relation to the relevant provisions, a replacement EU act means "an EU instrument which amends or replaces any of the EU instruments referred to in the third subparagraph of Article 5(1) of the Windsor Framework, the first indent of heading 1 of Annex 2 to the Framework or headings 7 to 47 of Annex 2 to the Framework" while a new EU act refers to a "new EU instrument which has been notified to the United Kingdom in accordance with Article 13(4) of the Windsor Framework".<sup>6</sup> The DSC may be notified by the UK Government if a new EU act or a replacement EU act has been proposed by the European Commission, or a replacement EU act has been published by the European Union.<sup>7</sup>

#### 2 New Initiatives in CWP 2025

The Commission's new initiatives, which are set out in Annex 1 of the CWP 2025, are listed under one of the following seven policy priorities;

- 1. A new plan for Europe's sustainable prosperity and competitiveness;
- 2. A new era for European defence and security;
- 3. Supporting people, strengthening our societies, and our social model;
- 4. Sustaining our quality of life: farming, food security, water, and nature;
- 5. Protecting our democracy, upholding our values;
- 6. A global Europe: leveraging our power and partnerships;
- 7. Delivering together and preparing our union for the future.

Each new initiative was presented against one of the Commission's policy objectives of simplification, competitiveness, decarbonisation, innovation, security, social fairness, migration, preparedness and resilience.

The new initiatives identified in CWP 2025 are categorized as legislative or non-legislative (policy). For the purposes of this paper, legislative initiatives with a subject area that was perceived to be sufficiently within the scope of the Windsor Framework/Protocol to result in a replacement or new EU act were identified. An initiative was considered to be within scope, if it related to the general policy areas covered by the subheadings in the annexes of the Windsor Framework. Whilst CWP 2025 provides a brief synopsis of the areas covered by new initiatives, there is limited detailed information on the content and scope of the new initiatives. It was, therefore, often challenging to assess the likelihood of these initiatives translating into new or replacement EU acts.

Analysis of the CWP 2025 highlighted nine new legislative initiatives that might be relevant to the work of the DSC. The nine initiatives are listed in Appendix 1 to this paper. Of these nine new legislative initiatives, six were considered to be likely to result in a replacement or new EU act, while three could result in a replacement or new act. A short description of each of the nine new initiatives is provided below under the relevant policy priority.

2.1 A new plan for Europe's sustainable prosperity and competitiveness

Under this policy priority, four new initiatives were identified as potential new or replacement EU acts. The **Third Omnibus Package, including on small mid-caps and removal of paper requirements** is intended to extend proportionality to mid-caps<sup>8</sup> by creating a new category of small mid-caps with adapted requirements and reduce reporting obligations as outlined in the Draghi report on competitiveness. The package is intended to ensure coherence and address the consequences of interactions between different pieces of legislation and may include proposals to remove inefficient requirements for paper formats in product legislation.<sup>9</sup> This initiative was considered likely to result in new or replacement EU acts, as product legislation is included within multiple subheadings within Annex 2 of the Windsor Framework.

The **Targeted Revision of the REACH Regulation** is intended to provide a simpler regime for the registration, evaluation and authorisation of chemicals and clarity on forever chemicals. This will likely result in a replacement or new EU act, as the REACH regulation ((EC) 1907/2006) currently falls within subheading 23 (Chemicals and Related), Annex 2 of the Windsor Framework.

The new **Digital Package** initiative could result in a new or replacement EU act. This package will likely cover overarching elements of legislative initiatives including cybersecurity, data protection, AI and digital networks, and will build consistency for data protection and cybersecurity rules. <sup>10</sup> While these areas are not listed in Annex 2 of the Windsor Framework, some elements of the AI Act

have resulted in replacement EU acts. There is, therefore, the possibility that an EU act relating to cybersecurity or AI could potentially result in a new EU act.

The final new initiative identified under this policy priority is the **Industrial Decarbonisation Accelerator Act,** which aims to support and increase demand for EU-made clean products, by introducing sustainability, resilience and "made in Europe" criteria in public and private procurements. <sup>11</sup> The act will support energy intensive industries, <sup>12</sup> and is potentially relevant to EU legislation in subheading 26 (Environment and energy efficiency) of Annex 2 of the Windsor Framework. It could, therefore, result in a replacement or new EU act.

#### 2.2 A new era for European Defence and Security

Three new initiatives that are likely to result in a replacement or new EU act were identified under this Commission policy priority. These include the Critical Medicines Act, which is intended to address the EU's dependence on non-EU countries for active pharmaceutical ingredients, intermediates, and other pharma ingredients and may likely result in a replacement or new act relevant to subheading 20 (Medicinal products) of Annex 2 of the Windsor Framework. Similarly, the New Rules on Drug Precursors initiative, which seeks to strike a balance between the necessary control of drug precursors whilst facilitating legitimate trade, is relevant to subheading 23 (Chemicals and related) of Annex 2 of the Windsor Framework and may likely result in a replacement or new EU act. In addition, the Firearms Trafficking Directive is likely to result in a replacement or new EU act under subheading 47 (Other) in Annex 2 of the Windsor Framework, given that similar legislation, which has is already been amended or replaced, is contained within Annex 2 of the Windsor

Framework. For example, in January 2025, Regulation (EU) 2025/41<sup>13</sup> on import, export and transit measures for firearms, essential components and ammunition, was notified to the DSC.

#### 2.3 Sustaining our quality of life: food security, water, and nature

Under this policy priority, two new initiatives have the potential to result in replacement or new acts. The **Common Agricultural policy simplification package,** which aims to simplify administrative burdens on farmers, is likely to result in replacement or new EU acts across several areas and subheadings under Annex 2 of the Windsor Framework. In addition, the **European Climate Law,** which intends to enshrine in legislation the EU's proposed 90% emission-reduction target for 2040, may impact on subheading 26 of Annex 2 (Environment and energy efficiency) of the Windsor Framework and could result in a replacement or new EU act.

#### 3 Evaluation and Fitness Checks

In Annex II of the CWP 2025, the Commission sets out its plans for evaluations and fitness checks on a number of EU laws, policies and EU programmes. An evaluation assesses a specific law, policy or funding programme for effectiveness, efficiency, relevance, coherence and EU added value. A fitness check focuses on 'identifying how different laws, policies and programmes interact, any inconsistencies or synergies, and their collective impact.'<sup>14</sup>

Analysis of evaluation and fitness checks identified eleven relevant to Annex 2 of the Windsor Framework and the remit of the DSC (see Appendix 2 of this paper). Of the eleven, five reference EU laws within Annex 2 of the Windsor Framework. These include: the evaluation of EU rules on medical devices and in vitro diagnostics; the radioactive waste directives; the Pressure

Equipment Directive and the Simple Pressure Vessels Directive; the EU Lifts Directive; and the Defence Transfers Directive. The six remaining fitness checks fell within the general areas covered by the subheadings in Annex 2 of the Windsor Framework. These fitness checks relate to: digital policy; energy security architecture; the evaluation of EU rules of origin; the Firearms Directive; and the interim evaluations of the Customs 2021-2027 and Customs Control Equipment Instrument (CCEI) programmes.

# 4 Pending Proposals

The CWP 2025 highlighted that the Commission had examined all proposals that were pending adoption at the start of its mandate to assess whether they should be maintained, amended or withdrawn. This decision was made in light of the policy priorities set for the new mandate and prospects of the proposal being adopted in the near future.<sup>15</sup> Annex III of the CWP 2025 contains the pending proposals that are to be maintained or amended in the new mandate.

In this paper, legislative proposals were selected as potential replacement or new EU acts, that could be notified to the DSC, if they met at least one of the following criteria:

- they contained a reference to amending or repealing an EU act contained in the relevant parts of Annex 2 of the Windsor Framework; or
- the associated documentation on the EU's online database (EUR-LEX)
   contained a reference to the Windsor Framework; or
- the relevant EU or UK Government explanatory memoranda indicated that the proposal related to a replacement EU act.

Of the one hundred and twenty-three pending proposals, twenty-three were identified as potential replacement or new EU acts having met at least one of the above criteria. These twenty-three proposals are listed in Appendix 3 of this paper.

Of the twenty-three proposals, eleven that met at least one of the above criteria had also been previously identified in the Executive Office's EU legislative table provided to the DSC as likely to result in a potential new or replacement EU act. An additional twelve proposals, which had not previously been identified in the Executive Office's EU legislative table, <sup>16</sup> were identified as a potential new or replacement EU acts (having met at least one of the above criteria). These proposals include: a new directive establishing a common data platform on chemicals under subheading 23 on Chemicals and Related in Annex 2 of the Windsor Framework; a new directive on preventing plastic pellet losses to reduce microplastic pollution under subheading 25 on Waste; a Regulation on the use of railway infrastructure capacity in the single European railway area under subheading 28 on Rail Transport; a Regulation on compulsory licensing for crisis management amending legislation under subheading 7 (Other); and a new Regulation on Plant Protection products under subheading 45: Intellectual Property of Annex 2 of the Windsor Framework.

A further seven proposals which fell within the general scope of Annex 2 of the Windsor Framework are highlighted in Appendix 3 of this paper. These proposals were considered within scope, as they fell within the general policy areas covered by the subheadings in Annex 2 of the Windsor Framework. However, these proposals did not meet the criteria of containing a reference to amending or repealing an act listed in Annex 2 of the Windsor Framework or contain a reference in EUR-LEX or the relevant EU-UK Explanatory Memoranda to the Protocol/Windsor Framework<sup>17</sup>. Any changes to these proposals throughout the legislative process could result in a new or replacement act. Therefore, they may still have the potential to result in a new or replacement act and should be noted.

#### 5 Withdrawals and Repeals

Following the Commission's assessment of pending proposals, thirty-seven proposals pending agreement were listed in Annex IV of the CWP 2025 to be withdrawn. In addition, four current regulations and decisions were listed for repeal in Annex V. No proposals that had previously been identified in the Executive Office's EU legislative table as a new or replacement EU act are to be withdrawn or repealed. However, one proposal, for a **Regulation on restricting the use of genetically modified food and feed** which could have amended a regulation under subheading 35 on GMO's, is to be withdrawn.

#### 6 Conclusions

Overall, examination of the CWP 2025 identified fifty initiatives (nine new initiatives; eleven evaluation and fitness checks; twenty-three pending proposals; and seven possible pending proposals) which could potentially result in a new or replacement EU act and be notified to the DSC. These fifty initiatives are listed in the appendices to this paper. It should be noted, however, that this is not a definitive list and there is a lack of publicly available information on the content and scope of some of the new initiatives. New initiatives and pending proposals may have been identified that subsequently are found not to result in a new or replacement EU act, whilst conversely, other initiatives or proposals which have not been identified in this analysis may subsequently be notified to the DSC. However, regular tracking of these initiatives and proposals, as they proceed through the EU legislative process, should identify those that ultimately will result in a new or replacement EU act under the Windsor Framework. While the current assessment has focused on legislative initiatives for the coming year, it is acknowledged that non-legislative strategies and policies developed within the 2025 CWP may result in legislative proposals that could be relevant to the Windsor Framework in this and future years and these should also be tracked.

### 7 Next Steps

In the forthcoming 2025 Joint Declaration on the EU's legislative priorities the European Parliament, the Council and the Commission will together set out a number of proposals for priority treatment in the legislative process. Before presenting legislative proposals to the European Parliament and the Council, the Commission conducts a thorough impact assessment, evaluating the potential economic, social, and environmental impacts of a policy. This assessment includes input from non-governmental organisations, national authorities, industry experts, and EU advisory bodies. In his statement on enhanced engagement with stakeholders in Northern Ireland, the Commission committed to ensuring that the views of stakeholders are heard on proposed EU laws that apply to Northern Ireland under the Windsor Framework. This enhanced engagement is to include:

- annual presentations and consultations on upcoming policy initiatives and legislative proposals;
- discussion of the CWP in the Joint Consultative Working Group;
- dedicated information sessions and workshops on request;
- a Windsor Framework webpage providing access to the latest proposals and relevant consultations; and
- impact assessments with a Northern Ireland focus.

While the scope of engagement appears relatively clear, questions remain regarding: where and when engagement with stakeholders will occur; how they can request information sessions or workshops on new initiatives, and whether or not the consultation mechanisms provided will extend beyond the Commission's existing 'Have Your Say'<sup>21</sup> and 'Impact Assessment'<sup>22</sup>

consultations. No formal mechanism exists for exchange of information between the Commission and the Northern Ireland Assembly. Nevertheless, a wider general awareness of the opportunities to share their views on new EU policies and existing laws with the Commission may facilitate the work of the DSC.
