The meeting began in closed session at 10.06am.

The Chairperson declared the meeting open to the public at 10.53am.

Michael Copeland MLA left the meeting at 10.54am.

1. Apologies

2. Draft Minutes

Agreed: The draft minutes of the meeting held on 15 May were agreed.

3. Chairperson's Business

The Chairperson note that the 2014 Survey of Services provided by the Assembly Commission is underway and encouraged members to complete this before the closing date of 6 June.

4. Matters Arising

- 4.1 The Chairperson noted that the Committee motion on a prayer of annulment in respect of SR133/2014 would be debated in the Assembly on Monday 2 June. He noted that he would speak to the motion as Chair of the Committee and members of the Committee may wish to contribute to the debate.

The officials briefed the Committee on the Social Security Agency's plans for engaging with employers on Universal Credit following the introduction of Welfare Reform and took questions from the Committee.

Members expressed some concern about the timing of engagement programme given that the Welfare Reform Bill has yet to be passed by the Assembly.

Officials acknowledged this point but noted that they were working on the assumption that the Bill would be passed at some stage and it was therefore necessary to raise awareness among employers about the potential impact of Universal Credit in anticipation of this happening

8. SL1 The Social Security (Recovery of Benefits) (Lump sum payments) (Amendment) Regulations (Northern Ireland) 2014

Agreed: The Committee was content for the Rule to be made.

9. SL1 The Child Support (GB Reciprocal Arrangements) (Amendment) Regulations (Northern Ireland) 2014

Agreed: The Committee was content for the Rule to be made.

10. SR 138/2014 The Child Support, Pensions and Social Security (2000 Act) (Commencement No. 12) Order (Northern Ireland) 2014

The Committee noted the commencement order.

11. SR 140/2014 The Social Security (Maternity Allowance) (Miscellaneous Amendments) Regulations (Northern Ireland) 2014

The Committee considered the Statutory Rule and the Department's response to the Committee's queries regarding the SL1 relating to the regulations.

Agreed: The Committee agreed to defer consideration of the regulations until a briefing by departmental officials could be arranged to provide further clarification on some aspects of the regulations.

- 12.1 *Agreed:* Members agreed that they would consider the Work and Families Bill and raise any comments before the deadline of 23 June.
- The Committee agreed remaining correspondence as outlined on the correspondence memo.

13. Forward Work Programme

14.1 *Agreed:* With reference to the June Monitoring Round briefing, the Committee agreed to write to the NI Housing Executive and ask for a profile of the proposed spend of its maintenance allocation for this year.

14.2 *Agreed:* The Committee agreed to write to the NI Federation of Housing Associations (NIFHA) asking for their comments on the current barriers to building additional social homes and the progress made to address these..
