The Chairperson declared the meeting open to the public at 10.05am.

### 1. Apologies

Apologies were as noted above.

### 2. Draft Minutes

Agreed: The draft minutes of the meeting held on 29 May were agreed.

Michael Copeland MLA joined the meeting at 10.06am.

### 3. Chairperson's Business

The Chairperson noted that the Committee would carry out its regular business, break for lunch and then reconvene in the afternoon to take evidence on the Inquiry.

### 4. Matters Arising

- 4.1 The Chairperson noted a letter from the Department regarding the current status of negotiations between maintenance contractors and the NIHE. Members noted that they had been led to believe that negotiations had concluded in agreement and approval was now being sought from DSD and DFP.
  Agreed: The Committee agreed to seek a briefing from officials in order to clarify this issue.
- 4.2 The Chairperson reminded members that the Committee for Employment and Learning has sought the Committee's input to the Work and Families Bill. *Agreed:* If no members seek to make comment on the Bill prior to 19 June, a nil response will be issued to the Committee for Employment and Learning.
- 4.3 The Chairperson reminded members that an additional meeting is scheduled for Tuesday 10 June to review evidence relating to Phase 1 of the Committee's Inquiry and to agree the timescale for completion of the Inquiry.

  \*Agreed: The Committee agreed that it was content to schedule additional extra briefings, if required, following the meeting on 10 June.
- 4.4 *Agreed:* The Committee agreed to forward to the Department any information it has in relation to the Equality Commission's investigation into "potential failures by the DSD to comply with its approved Equality Scheme in connection with the Housing Strategy 2012-17".
- 4.5 The Chairperson reminded members that they are invited to attend an ETI workshop in the Long Gallery on Energy Efficiency on the morning of 10 June.

### 5. Regeneration and Housing Bill pre-introduction – Departmental Briefing

The following officials joined the meeting at 10.21am:

Trevor Clarke MLA joined the meeting at 10.22am.

The Chairperson noted that the Minister for Social Development intends to introduce the Bill to the Assembly before Summer Recess and that the Bill will be considered by the Executive this afternoon.

Members questioned officials on a range of issues regarding the proposed devolved powers, the impact on the department in terms of staffing, the engagement process, and expressed some concerns around the lack of a definition of the term 'social need' within the Bill.

The Chairperson reminded members that this was a pre-legislative briefing and that their concerns could be explored in more detail during Committee Stage of the Bill.

Agreed: The Department agreed to provide the Committee with a report on the effectiveness of engagement with councils to date; and examples of regeneration schemes that included social housing.

Agreed: The Department agreed to provide the Committee with information on potential DSD staff reductions as a result of powers being devolved to local councils.

Agreed: The Department agreed to seek confirmation on whether a definition of 'social need' should be included in the legislation.

Agreed: The Department agreed to provide the Committee with examples of regeneration schemes involving social housing being delivered by councils in conjunction with Housing Associations.

# **6.** Housing (Amendment) Bill consultation responses – Departmental Briefing The following officials joined the meeting at 11.11am:

Trevor Clarke MLA declared an interest in this briefing as a private landlord.

The Chairperson referred members to a letter from the Minister which acknowledged members' previously expressed concerns on this issue and noted his desire to proactively address anti-social behaviour among social housing tenants.

The Chairperson thanked the officials for extending the consultation period, as requested at the previous briefing on this matter.

The officials briefed the Committee on the consultation responses for the Housing (Amendment) Bill.

Members questioned the effectiveness of short secure tenancies to address anti-social behaviour and were of the view that the process to evict a tenant would be protracted.

Members acknowledged that there needed to be a balance between the rights of tenants to be free from the impact of anti-social behaviour and the rights of those engaged in such behaviour to be supported in order that they are not evicted and potentially made homeless.

Agreed: The Department agreed to provide information on how the legislation would assist in removing barriers in providing information on empty homes to Land and Property Services.

Agreed: The Department agreed to provide information on whether there was any obligation for a new tenant to be informed if a previous tenant left the property due to problems with anti-social behaviour in adjacent properties.

The officials left the meeting at 12.02pm.

# 7. Update on the Building Successful Communities Programme – Departmental Briefing

The officials briefed the Committee on the Department's 'Building Successful Communities' Programme, noting that this was the start of a three year programme and that they would be keen to return regularly to update the Committee on progress. They noted that a seminar would be held in September with forums from the areas that are currently being targeted for housing-led regeneration.

The Chairperson noted the delay in the implementation of the scheme, given the Minister made the announcement in October 2013. Officials noted that there had been a significant delay in implementing neighbourhood renewal and that they sought to learn lessons from this and aim to expedite the Building Successful Communities Programme.

Members addressed some other concerns but acknowledged that the programme is in its early stages.

*Agreed:* The officials agreed to return to brief the Committee immediately following the seminar in September.

# 8. Draft SR The Business Improvement Districts (Miscellaneous) Regulations (Northern Ireland) 2014

The Committee had no objections to the Rule.

# 10. SR 140/2014 The Social Security (Maternity Allowance) (Miscellaneous Amendments) Regulations (Northern Ireland)

The Chairperson noted that the Committee had queried these regulations, specifically with regards to the definition of terms that determined whether a person was eligible for Maternity Allowance (MA).

The Departmental officials confirmed that the term 'take due care of her health' although not defined in legislation has been included in legislation since 1948. They noted that they had been unable to find an example of this being used as a reason to disqualify a person from receiving MA in the last 27 years.

Members of the Committee expressed concern that the lack of definition within the legislation left ambiguity in the phrasing that could potentially allow arbitrary judgements to be made with regards to whether MA is granted and that this represented a larger issue that needed addressed.

Some members questioned why it was necessary to have these provisions at all given that they had not been used once in 27 years.

Officials advised that the effect of annulling these regulations was that it would create a situation where one group of women was subject to existing disqualification provisions and another group would not.

Following discussions the Chairperson proposed the following motion to the Committee: That the Committee for Social Development has considered the Statutory Rule SR 140/2014 The Social Security (Maternity Allowance) (Miscellaneous Amendments) Regulations (Northern Ireland) and recommends that it be annulled by the Assembly.
