## 1. Apologies

## 2. Draft Minutes

Agreed: The draft minutes of the meeting held on 26 November 2015 were agreed.

#### 4. Matters Arising

The Committee noted that the Licensing Bill has its Second Stage on Monday 7 December 2015.

*Agreed*: The Committee agreed to the issue of a Call for Evidence on 8 December, subject to the Bill being referred to the Committee by the Assembly.

*Agreed:* In order to ensure that the Bill passes through all necessary stages before the end of the mandate, the Committee agreed that the Call for Evidence will close on Thursday 31<sup>st</sup> December 2015.

*Agreed:* The Committee agreed its draft event programme 'Building future homes – providing choice, sustaining supply'. This event is being held in conjunction with CIH and is scheduled to take place at the Stormont Hotel on 21 January 2016.
